VENKATESWARALU AGAINST THE ORDER NO.2098 DATED 17/04/2017 OF  
CENTRAL PUBLIC INFORMATION OFFICER (CPIO) OF SIDBI REGARDING  
HIS RTI APPLICATION DATED 14/03/2017.**

**Background:**

The Appellant Shri K Venkateswaralu having his address as Door No.30, Flat No.SF 2, Casa Blanka Flats, Velachery By-Pass Road, Velachery, Chennai 600 042, has preferred the present appeal dated June 07, 2017, received on June 14, 2017, against the order No. 2098 dated April 17, 2017 by CPIO of Small Industries Development Bank of India (SIDBI) in response to his application received on March 21, 2017, seeking information/details with regard to Shri K V Gopikrishna, DGM, SIDBI, Chennai.

The Appellant has challenged the said order dated April 17, 2017 of CPIO inter alia, on various grounds alleging that the information is not provided fully by CPIO claiming exemption u/s 8(1)(j) being personal information of the staff.

I have gone through the contents of the Appeal dated June 07, 2017, the application dated March 14, 2017 of the appellant as also the order No.2098 dated April 17, 2017 passed by CPIO in the matter. It is observed that the appellant has sought various informations regarding Shri K V Gopikrishna, Dy.General Manager working in SIDBI, Chennai Branch.

I observe that the CPIO has provided the information which can be provided and has very aptly claimed exemption u/s.8(1)(j) about the personal information of staff member. CPIO has held that disclosure of personal information has no larger public interest.
