AGAINST ORDER NO.2256 DATED OCTOBER 18, 2017 OF
CENTRAL PUBLIC INFORMATION OFFICER (CPIO) OF SIDBI
REGARDING HIS RTI APPLICATION RECEIVED ON NOVEMBER 14, 2017.**

Background:

The Appellant, Dr. Mani M, Divisional Manager, CRM Dept / CPIO, Life Insurance Corporation of India, Mumbai DO-III, New India Bldg., 1st Floor, S. V. Road, Santacruz (West), Mumbai-400054 has preferred the present appeal dated November 08, 2017 against the Order No.2256 dated October 18, 2017 by CPIO of Small Industries Development Bank of India (SIDBI) received on November 14, 2017.

Not satisfied with the said order, the appellant has preferred this appeal, requesting intervention of FAA in providing him information sought by him in his RTI application

Observations :

I have gone through the contents of his Appeal dated November 08, 2017, as also the order No.2256 dated October 18, 2017 passed by CPIO in the matter. It is observed that vide his above RTI application, the appellant had sought information relating to recruitment, transfer, promotion, mobility, leave, VRS Scheme introduced in Bank last time, benefits to employees of SIDBI.

The Appellant has made this appeal on the following grounds i.e. i) The nutshell of the RTI Act means whatever information, that can be provided to Parliament of India shall

be provided to the citizen of India, ii) Requested to provide the information in the available format without diverting the resources in terms of man power, costs and time and iii) RTI applicant need not disclose the information as provided and the reason for requesting the information is to provide suggestions officially on Draft Transfer Policy as requested by LIC of India. It is observed that appellant in his appeal has only raised statement of facts and no grievance has been made in his appeal as a ground of appeal.

I observe that information with respect to the queries at Sl. no. 1, 2, 5, 9 & 10 of his application dated September 16, 2017 had been provided and attended to by, inter alia, stating that requested information is available on SIDBI website at www.sidbi.in. The information with respect to queries at Sl. 3,4,6,7 & 8 had not been provided as available exemption has been claimed under Section 8(1)(d) of the RTI Act. As no larger public interest warrant the disclosure of such information as raised by the applicant in the queries at Sl. No. 3, 4, 6, 7, & 8, therefore, CPIO is rightly mentioned the exemption under RTI Act. It is also observed that available information has already been provided and RTI application has been disposed off as per the provisions of RTI Act.

Order :

I find no infirmity with the impugned order passed by CPIO, the appeal is accordingly disposed off.
