**APPEAL UNDER SECTION 19(1) OF THE RTI ACT BY MS. NAVEED  
AGAINST ORDER NO.2294 DATED DECEMBER 08, 2017 OF  
CENTRAL PUBLIC INFORMATION OFFICER (CPIO) OF SIDBI  
REGARDING HIS RTI APPLICATION RECEIVED ON DECEMBER 11, 2017.**

**Background:**

The Appellant, Ms. Naveed, A17/82A, Pathani Tola, Varanasi, PIN: 221001, Uttar Pradesh has preferred the present appeal dated November 09, 2017 against the Order No.2294 dated December 08, 2017 by CPIO of Small Industries Development Bank of India (SIDBI) received on December 11, 2017.

Not satisfied with the said order, the appellant has preferred this appeal, requesting intervention of FAA in providing him information sought by him in his RTI application.

**Observations :**

I have gone through the contents of his Appeal dated December 09, 2017, as also the order No.2294 dated December 08, 2017 passed by CPIO in the matter. It is observed that vide his above RTI application; the appellant had sought information relating to year wise sanction and disbursement to different States and UTs, year wise sanction and disbursement under promotional and developmental activities and year wise growth in number of customers during the period from 2006-07 to 2016-17.

The Appellant has made this appeal on the following grounds i.e. i) CPIO Provided incomplete, misleading or false information ii) Annexure are not enclosed.
