APPEAL UNDER SECTION 19(1) OF THE RTI ACT BY SHRI P R K SESHAGIRI RAO, GPA HOLDER OF SAI PRASANNA PLASTIC INDUSTRIES, AGAINST ORDER NO.2000 DATED NOVEMBER 16, 2016 OF CENTRAL PUBLIC INFORMATION OFFICÉR (CPIO) OF SIDBI REGARDING HIS RTI APPLICATION DATED OCTOBER 20, 2016.

## Background:

The Appellant, Shri P R K Seshagiri Rao, GPA Holder of Sai Prasanna Plastic Industries, Plot No.65, IDA, Phase III, Patancheru, Medak District 502319, Teangana State has preferred the present appeal dated December 06, 2016 against the Order No.2000 dated November 16, 2016 by CPIO of Small Industries Development Bank of India (SIDBI) in response to his application dated October 20, 2016.

Not satisfied with the said order, the appellant has preferred this appeal, requesting intervention of FAA in providing him correct picture/information sought by him in his RTI application.

## **Observations:**

I have gone through the contents of his Appeal dated December 06, 2016, the application dated October 20, 2016 of the appellant as also the order No.2000 dated November 16, 2016 passed by CPIO in the matter. It is observed that vide his above RTI application, the appellant had sought the status of CLCSS subsidy claim of ₹3,14,000/- from SIDBI alleged to be submitted by Central Bank of India in respect of Sai Prasanna Plastic Industries and the reasons of delay in settlement of the same.

I also notice that the appellant has given reference/details of subsidy application moving from Main Branch to Zonal Office of Central Bank of India, however, no details i/r/o application submitted to SIDBI are mentioned.

Based on records available with SIDBI as informed to CPIO, applicant was informed and as per SIDBI records, no such application was received.

## Order:

In view of the above, I find no infirmity in the order passed by CPIO and accordingly appeal is dismissed.
