CENTRAL PUBLIC INFORMATION OFFICER (CPIO) OF SIDBI  
REGARDING HIS RTI APPLICATION DATED OCTOBER 06, 2016.**

**Background:**

The Appellants, S/Shri Gunvantbhai Ghelabhai Naik and Nareshbhai Ghelabhai Naik Siddharth Apartment, 1<sup>st</sup> Floor, Near Gayatri Dairy, Vapi – 396191, have preferred the present appeal dated December 24, 2016 against the Order No.2012 dated November 28, 2016 by CPIO of Small Industries Development Bank of India (SIDBI) in response to their application dated October 06, 2016.

Not satisfied with the said order, the appellants have preferred this appeal, requesting intervention of FAA in providing them correct picture/information sought by them in their RTI application.

**Observations :**

I have gone through the contents of their Appeal dated December 24, 2016, the application dated October 06, 2016 as also the order No.2012 dated November 28, 2016 passed by CPIO in the matter. It is observed that vide their above RTI application, the appellants had sought information regarding documents taken by SIDBI while sanctioning the term loan of Rs.25.20 crore to Vapi Infrastructure and Industrial Township Ltd (VIITL), details of principal/interest amount paid by Prashant Developer, Tirupati Shelters, Nagajun

Developers in lieu of repayments and also requested certified copies of Bank Statements of the above parties.

I observe that the CPIO has provided the information with regard to its borrower (VIITL) which could be provided and has clarified them about the non-submission of Bank Statements, held by SIDBI in fiduciary capacity claiming exemption under section 8(1)(d) and (e) of RTI Act.

**Order :**

In view of the above, I find no infirmity in the order passed by CPIO and appeal is devoid of any merit and accordingly appeal is dismissed.
