**APPEAL UNDER SECTION 19(1) OF THE RTI ACT BY SHRI PRAVEEN KUMAR VIJ, AGAINST ORDER NO.2023 DATED JANUARY 06, 2017 OF CENTRAL PUBLIC INFORMATION OFFICER (CPIO) OF SIDBI REGARDING HIS RTI APPLICATION DATED DECEMBER 05, 2016.**

**Background:**

The Appellant, Shri Praveen Kumar Vij, Proprietor Kanishk Packaging Industries, H.No.461, Second Floor, Shakti Khand 4, Indirapuram, Ghaziabad, Uttar Pradesh 201014 has preferred the present appeal dated January 30, 2017 against the Order No.2023 dated January 06, 2017 by CPIO of Small Industries Development Bank of India (SIDBI) in response to his application dated December 05, 2016.

Not satisfied with the said order, the appellant has preferred this appeal, requesting intervention of FAA in providing him information sought against question No. 2, 3, 4, 6, 7 and 10 to 13 of his above application.

**Observations :**

I have gone through the contents of his Appeal dated January 30, 2017, the application dated December 05, 2016 of the appellant as also the order No.2023 dated January 06, 2017 passed by CPIO in the matter. It is observed that vide his above RTI application, the appellant had sought information from SIDBI relating to its NPA clients of last three years specifically in the area of NCR, U.P. and details of OTS proposal received from them.

I observe that most of the queries of the appellant vide his application dated December 05, 2016 had been attended. However, information w.r.t. his query at Sr.No.2, 3, 4, 6, 7 and 10 to 13 pertains to various borrowers i.e. third party information which is held by SIDBI in commercial confidence as also in fiduciary capacity hence denial, seeking exemption under Section 8(1)(d) and (e) of RTI Act. I observe that appellant has tried to explain what he meant by query, if applicant wants some other information, he can make fresh application to CPIO.

**Order :**

In view of the above, I find no infirmity in the order passed by CPIO and appeal is devoid of any merit and accordingly dismissed.
