APPEAL NO. A-08/2020-21 BEFORE APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Shri Omprakash Kanshiram, Amol Apartment, 3/16, Waldhuni, Kalyan, Pin:421301, has preferred the present appeal dated September 10, 2020 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on September 14, 2020 against the letter number 211346 / RTI-5 /2921 dated September 04, 2020 passed by CPIO, requesting intervention of FAA in providing information sought by him in the RTI application.

Observations:

I have gone through the contents of his appeal dated September 10, 2020 as also the letter number 211346 / RTI-5 /2921 dated September 04, 2020 passed by CPIO in the matter. It is observed that vide his RTI application dated July 08, 2020, the appellant has sought information on - The Central Government has issued fund to Micro and Small Industries Enterprises of India. Are getting packages for loss during lockdown. The Government of India has provided loan packages to MSMEs in all over of India. I want information for details of all MSMEs in all over of India with distribution of loans to each MSMEs. RBI is also declared on the same line to provide the loan to MSMEs and NABARD, SIDBI, National Housing Bank; 1) Please provide documents duly attested by PIO with name and designation under section 5(1) and 20 of RTI Act 2005 regarding the names of all MSMEs those have been taken benefits under packages, 2) Please provide the documents under section 5(1) and 20 of RTI Act 2005 regarding the mode of payment to MSMEs, 3) Please provide documents duly attested by PIO with name and designation under section 5(1) and 20 of RTI Act 2005 regarding the distribution of amounts of packages in all states wise of India, 4) Please provide documents duly attested by PIO with name and designation under section 5(1)

are/were taking loan under packages, 5) Please provide the documents under section 5(1) and 20 of RTI Act 2005 regarding the total MSMEs are getting benefits under packages and names of MSMEs, 6) Please provide the documents under Section 5(1) and Section 20 of RTI Act 2005 regarding total NPA upto 08.07.2020 through MSMEs all over of India with banks wise details may be provided, 7) Please provide documents duly attested by PIO with name and designation under section 5(1) and 20 of RTI Act 2005 regarding the total MSMEs in all over of India those have been eligible for get packages with name and address of MSMEs, 8) Please provide documents duly attested by PIO with name and designation under section 5(1) and 20 of RTI Act 2005 regarding the name of MSMES with address of those are 'Kangal' (defaulters) totally 10 months during KOVID-19" those are requiring packages from Central Government, 9) Please provide documents duly attested by PIO with name and designation under Section (1) and Section 20 of RTI Act 2005 regarding total amount handed over to NABARD as per the media announcement through Central Government and RBI, Mumbai, 10) Please provide documents duly attested by PIO with name and designation under Section 5(1) & 20 of RTI Act 2005 regarding total amount handed over to SIDBI as per the media announcement through Central Government and RBI, Mumbai and 11) Please provide the documents duly attested by PIO with name and designation under Section 5(1) and 20 of RTI Act 2005 regarding total amount handed over to National Housing Bank as per the announcement through Central Government and RBI, Mumbai.

Not satisfied with the reply given by the CPIO, the Appellant has made his appeal on the grounds that information not provided by PIO.

I observe the following, on the various points raised by the appellant in the RTI appeal dated September 10, 2020:

- (a) Information has been provided by the CPIO, except those information, which are exempted under RTI Act 2005.
- (b) Certain information have not been provided by the CPIO as the same is exempted under section 8(1)(d) & (e) of RTI Act 2005. Regarding the serving of notice

to third parties under section 11 of RTI Act, CPIO may advise the status to the Appellant.

(c) & (e) CPIO is instructed to send the annexure of the information, provided

to the appellant, duly attested with the seal and signature with blue pen, clearly

indicating the name and designation, within 20 days of the date of this order.

(d) The information on NPAs of MSMEs borrowers in SIDBI as on 08.08.2020

has been provided in the CPIO order. As regards providing documents related to total

NPAs of MSMEs, the Appellant may request for the same through a separate RTI

application indicating the specific documents desired by him.

(f) The information on the Special Liquidity Package has been provided in CPIO

order. CPIO is instructed to provide the Appellant, the print out of the RBI Governor's

statement dated April 17, 2020, which has been extracted by TRMV, Mumbai from

RBI's website and forwarded to RTI Cell.

(g), (h), (j) & (k) These are general comments of the appellant and does not

form part of information in the RTI application.

(i) The CPIO order has been issued within the stipulated time as per RTI Act

from the date of receipt of application.

The RTI mechanism is meant for providing available information which is not

exempted under the provisions of RTI Act.

Order:

The appeal is accordingly disposed of. Copy of this order be sent to the

appellant and CPIO.
