## APPEAL No.04/2018-19 BEFORE FIRST APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

## Background:

The Appellant, Shri Ajay Kumar Yadav, 93\_b gyatri nagar, Jaipur, PIN: 302018 has preferred the present appeal dated July 30, 2018 under section 19(1) of RTI Act (received by office of First Appellate Authority (FAA) on July 30, 2018) against the Order No.2432 dated July 25, 2018 passed by CPIO requesting intervention of FAA in providing information sought by him in the RTI application.

## Observations:

I have gone through the contents of his Appeal dated July 30, 2018, as also the order No.2432 dated July 25, 2018 passed by CPIO in the matter. It is observed that vide his RTI application dated July 04, 2018, the appellant had sought various information regarding the Stand Up India Scheme i.e.1) How much money is given as loan under Stand Up Scheme, 2) How many number of people get benefitted by this scheme and 3) What are the reasons for its poor response and what has the Govt. done to boost the process of lending.

Not satisfied with the reply given by the CPIO, the Appellant has made this appeal on the grounds that CPIO has provided incomplete, misleading or false information and requesting now to provide how much total money is disbursed to all the benefited candidates and how much is given separately to persons belonging to SC and ST category.

I observe that information with respect to the query at SI. no.1 to 3 of his application dated July 04, 2018 had been provided by CPIO which is available with



concerned vertical / department and I did not find any incompleteness, misleading or false information about the information supplied. I found that the information supplied by CPIO is absolutely correct as raised by the information seeker in his RTI application dated July 04, 2018. Further, the Appellant did not mention in his appeal about the area of incompleteness, misleading or false information which was being provided by CPIO. However, now the Appellant has come out with a new question i.e. I want to ask how much total money is disbursed to all the benefited candidates and how much is given separately to persons belonging to SC and ST category which is not mentioned in his RTI application dated July 04, 2018. It is beyond the scope of the provision of RTI Act and appeal is rejected.

However, it is advised that if the Appellant wants to know the above information he may file a fresh RTI application to CPIO with applicable fees as per the provision of RTI Act.

## Order:

The appeal is accordingly disposed of.
