APPEAL No.16/2017-18 BEFORE
FIRST APPELLATE AUTHORITY UNDER
RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Dr. Prafulla Ranjan, 201, Raj Palace, Tagore Hill Road, Morabadi, Ranchi-834008, Jharkhand has preferred the present appeal dated January 06, 2018 under section 19(1) of the RTI Act, which was received by office of First Appellate Authority (FAA) on January 08, 2018, against the Order No.2309 dated January 02, 2018 passed by CPIO of Small Industries Development Bank of India (SIDBI) requesting intervention of FAA in providing information sought by him in his RTI application.

Observations :

I have gone through the contents of his Appeal dated January 06, 2018 as also the order No. 2309 dated January 02, 2018 passed by CPIO in the matter. It is observed that vide his above RTI application; the appellant had sought information relating to recruitment of MD in APITCO, Hyderabad i.e. copy of office note appointing screening committee and interview committee, copy of notes prepared by screening committee while screening the application, copy of application of all the persons shortlisted for interview, copy of note where I was found ineligible, copy of minutes of interview board, copy of marks awarded by each interview board member to each candidate, copy of tabulated sheet, education and experience certificate copy of candidates selected for interview, copy of application and experience plus education certificate of candidate finally selected for the post, names and designations of interview board panel, copy of original advertisement and copy of changes in eligibility criteria subsequently if any and copy of policy of company where it is written that 18 people can be called for interview against one post; normally, it is 4 to 5.

With respect to query at Sl. no. 1, 2 and 3, the Appellant has sought copy of office note appointing screening committee and interview committee, copy of notes prepared by screening committee while screening the application and copy of application of all the persons shortlisted for interview, CPIO rightly denied the information by quoting Section 8(1)(d) of RTI Act, 2005 since these documents contains information related to third parties and no larger public interest warrant the disclosure of these information. Therefore, the ground for appeal does not have any merit, it can not be entertained.

With respect to query at Sl. no. 7, the Appellant has sought copy of tabulated final sheet and CPIO has already supplied the information i.e. the final sheet containing the marks in respect of the Information Seeker, therefore, there is no merit in this appeal.

With respect to query at Sl. no. 8 & 9, the Appellant has sought education and experience certificates copy of candidates selected for interview and copy of application and experience plus education certificate of candidate finally selected for the post, CPIO rightly denied the information by quoting Section 8(1)(d) of RTI Act, 2005 since these information contains related to third parties and no larger public interest warrant the disclosure of these information. Further, copy of application, which contain, date of birth, address, Telephone/Mobile No., CTC, e-mail ids etc, which are personal in nature, and cannot be disclosed on various decisions as also under section 8(1)(d) of RTI Act. Therefore, the ground for appeal does not have any merit, it can not be entertained.

Order :


In view of the above, I find no infirmity in the order passed by CPIO and accordingly appeal is disposed off.


