**APPEAL No.17/2017-18 BEFORE
FIRST APPELLATE AUTHORITY UNDER
RIGHT TO INFORMATION ACT (RTI ACT), 2005**

Background:

The Appellant, Ms. Noor Fatima, Room No. B-203, Begum Sultan Jahan Hall, Qila Road, Purani Chungi, Aligarh Muslim University, Aligarh, Uttar Pradesh, PIN: 202001 has preferred the present appeal dated January 15, 2018 under section 19(1) of RTI Act (received by office of First Appellate Authority (FAA) on January 16, 2018) against the Order No.2277 dated November 10, 2017 passed by CPIO requesting intervention of FAA in providing information sought by her in the RTI application.

Observations :

I have gone through the contents of the Appeal dated January 15, 2018, as also the order No.2277 dated November 10, 2017 passed by CPIO in the matter. It is observed that vide her RTI application dated October 12, 2017, the appellant had sought information relating to NPA (Gross NPA, Net NPA, Gross Advances, Net Advances) of DFIs (Development Finance Institutions / Financial Institutions in India i.e. Small Industries Development Bank of India, SFCs and SIDCs).

I observe that with respect to Sl. no. 1 of the RTI Application, CPIO has supplied the relevant information as pertaining to SIDBI and there is no grievance by the Appellant in this regard.

Further, with respect to Sl. No. 2 of the RTI Application, the requested information was pertaining to SFCs and SIDCs and this information is not available with SIDBI. Therefore, CPIO has transferred the RTI Application to 18 SFCs and 30 SIDCs under section 6(3) of RTI Act and the same was intimated to Appellant vide letter no. 70692/RTI-5/2277-2278-2279 dated October 18, 2017. The ground for appeal as raised by Appellant in this regard is not related to SIDBI but to other Public Authorities. The obligation of CPIO to furnish the information arises in case the information is available with the Public Authority and the same is not exempted from the disclosure under the provisions of RTI Act. In this case as the requested information pertains to other Public Authority and CPIO has transferred the RTI application to such Public Authority, no case is made out to make appeal to SIDBI. In the light of the above background, the present appeal does not merit consideration.

Order :

I find no infirmity with the impugned order passed by CPIO, the appeal is accordingly disposed of.
