APPEAL No.21/2017-18 BEFORE FIRST APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Shri Santosh Pandey, B-1/209 Lohiya Nagar, St. Francis Road, Near Milan Subway, Vile Parle, West, Mumbai, PIN:400056 has preferred the present appeal dated February 20, 2018 under section 19(1) of RTI Act (received by office of First Appellate Authority (FAA) on February 21, 2018) against the Order No.2333 dated January 15, 2018 passed by CPIO requesting intervention of FAA in providing information sought by him in the RTI application as 30 days have been passed and no information received from Micro Units Development & Refinance Agency Ltd (MUDRA).

Observations:

I have gone through the contents of the Appeal dated February 15, 2018, as also the order No.2333 dated January 15, 2018 passed by CPIO in the matter. It is observed that vide his RTI application dated January 11, 2018, the appellant had sought information relating to MUDRA's recruitment.

I observe that the information sought by the Appellant is pertaining to MUDRA and this information is not available with SIDBI. Therefore, CPIO has transferred the RTI Application to MUDRA under section 6(3) of RTI Act and the same was intimated to Appellant vide letter no. 85441/RTI-5/2333 dated January 15, 2018. The ground for appeal as raised by Appellant in this regard is not related to SIDBI but to other Public Authority. case the information is available with the Public Authority and the same is not exempted from the disclosure under the provisions of RTI Act. In this case as the requested information pertains to other Public Authority and CPIO has transferred the RTI application to such Public Authority, no case is made out to make appeal to SIDBI. In the light of the above background, the present appeal does not merit consideration.

Order:

I find no infirmity with the impugned order passed by CPIO, the appeal is accordingly disposed of.
