**APPEAL NO. A-11/2019-20 BEFORE  
APPELLATE AUTHORITY UNDER  
RIGHT TO INFORMATION ACT (RTI ACT), 2005**

**Background:**

The Appellant, Shri Felix, 347, 2/3 Main, I Block, Ramakrishna Nagar, Mysore-570022, Karnataka, has preferred the present appeal dated July 20, 2019 under section 19(1) of RTI Act, which has been transferred to SIDBI by Department of Financial Services, Ministry of Finance vide its letter No. 25/141/2019-IF-II dated August 02, 2019 and received by office of First Appellate Authority (FAA) on August 13, 2019. The appeal is on the ground that there is no response within the Time Limit.

**Observations:**

I have gone through the contents of his appeal dated July 20 2019. It is observed that vide his RTI application dated June 17, 2019, which was transferred to CPIO, SIDBI by Department of Financial Services, Ministry of Finance vide its letter no. 25/119/2019-IF-II dated June 20, 2019 and received by CPIO, SIDBI on June 25, 2019, the appellant has sought information on 1) With reference to Section 3.1.1 mentioned in the RBI circular RBI/2010-11/79 RPCD.SME & NFS.BC. No. 9/06.02.31/2010-11 and recommendations of Prime Ministers Task Force on MSMEs, Provide me the soft copy of the information -performance of SIDBI Bank, Mysore District, Karnataka State in terms of estimates and actual figures of Adjusted Net Bank Credit (ANBC) or credit equivalent amount of Off-Balance Sheet Exposure, whichever is higher for the year 2010-18.

The Appellant has made his appeal on the grounds that information has not been provided within time limit.

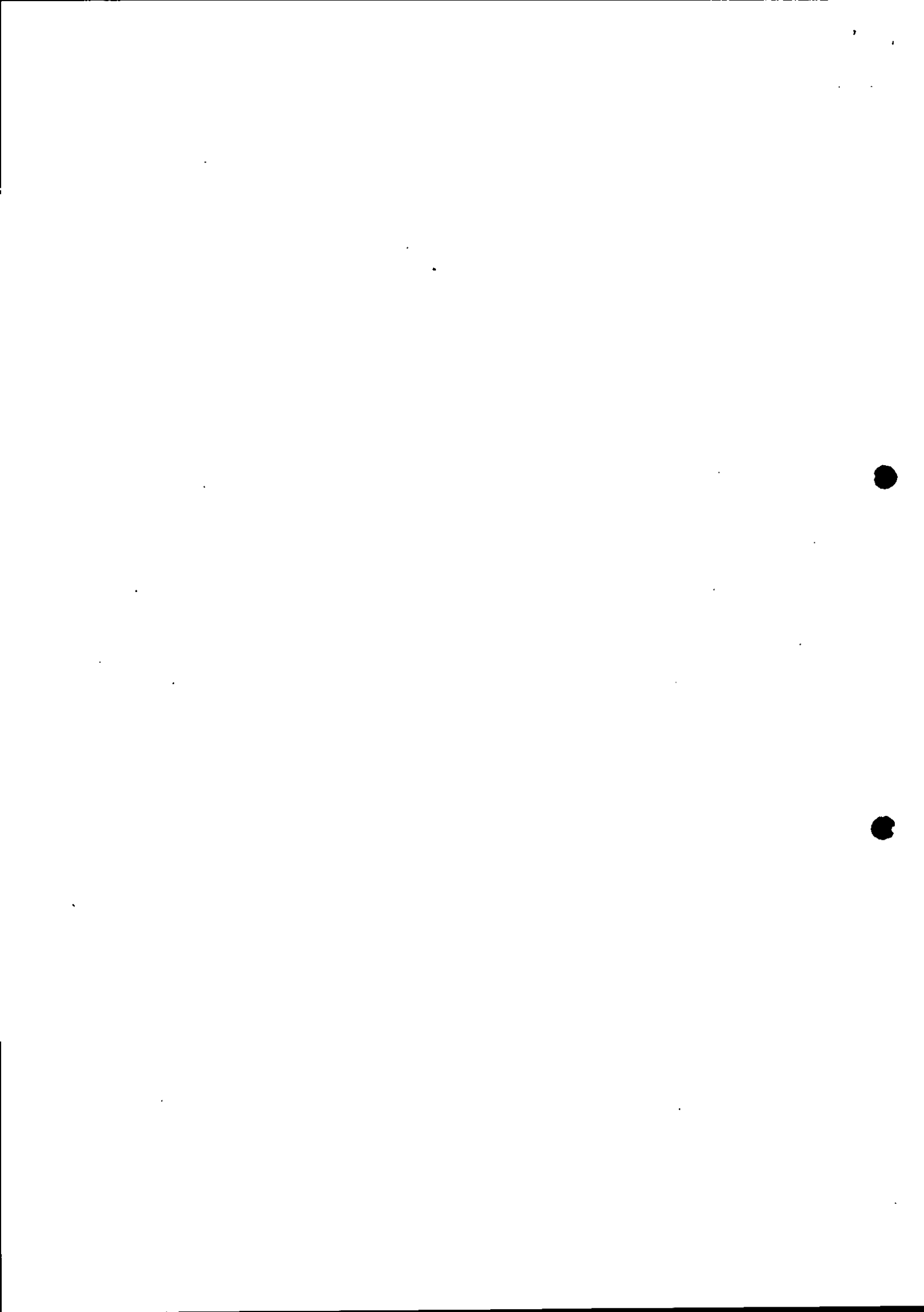
