**APPEAL NO. A-04/2020-21 BEFORE
APPELLATE AUTHORITY UNDER
RIGHT TO INFORMATION ACT (RTI ACT), 2005**

Background:

The Appellant, Shri Raghavan, S/o. M. Chelliah, 15, North Street, Ananthapuram, Thatchanallur, Tirunelveli, Pin:627358, Tamil Nadu, has preferred the present appeal dated May 17, 2020 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on May 17, 2020 against the letter number 197564 / RTI-5 /2883 dated May 13, 2020 passed by CPIO, requesting intervention of FAA in providing information sought by him in the RTI application.

Observations:

I have gone through the contents of his appeal dated May 17, 2020 as also the letter number 197564 / RTI-5 /2883 dated May 13, 2020 passed by CPIO in the matter. It is observed that vide his RTI application dated May 08, 2020, the appellant has sought information on - I am in need of the following information pertaining to status of Non Performing Assets (NPA), followed by deterioration in asset quality, against the bad loans sanctioned to Corporate (both Private and Public Limited Company) Sectors, during the past ten Financial Years, starting from FY 2010 2011 to FY 2019 2020 : 1) Company name, loan account, Asset Worth and Year End wise Amount of NPA declared, 2) Company name, loan account and Year End wise Amount of Recovery followed by incorporation of SARFAESI Act-2002 against the said NPA, 3) Company name, loan account and Year End wise List of bidders backing out after submitting final proposals, 4) Company name, loan account, Asset Worth and Year End wise Loan Account taken to Bankruptcy and subsequently referred to NCLT Court of Law, 5) Company name, loan account and Year End wise Amount of Recovery from the said stressed Accounts, if any, tried through Insolvency and Bankruptcy Code

(IBC). 6) In case of arrival of One Time Settlement, Company name, loan account, NPA amount, OTS arrival amount and year-end wise, 7) Company name, loan account and Year End wise Amount of Waiver declared along with the designation of the official, who authorized such waiver process, finally.

Not satisfied with the reply given by the CPIO, the Appellant has made his appeal on the grounds that refused access to information requested.

I observe that CPIO has provided the factual position to Appellant. The requested information has not been provided, as it is exempted under RTI Act.

The RTI mechanism is meant for providing available information which is not exempted under the provisions of RTI Act.

In view of the above, I do not find any infirmity in the order of the CPIO.

Order:

The appeal is accordingly disposed of. Copy of this order be sent to the appellant and CPIO.
