APPEAL NO. A-19/2019-20 BEFORE APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Ms Uma Muchhal, 38/351, Bijasan Bhawan South Ayad, Udaipur, PIN-313001, Rajasthan has preferred the present appeal dated January 07, 2020 under section 19(1) of R/TI Act and received by office of First Appellate Authority (FAA) on January 07, 2020 against the letter number 185248/ RTI-5 /2803 dated December 30, 2019 passed by CPIO, requesting intervention of FAA in providing information sought by her in the RTI application.

<u>Observations:</u>....

I have gone through the contents of her appeal dated January 07, 2020 as also the letter number 185248/ RTI-5 /2803 dated December 30, 2019 passed by CPIO in the matter! It is observed that vide her RTI application dated December 12, 2019, the appellant has sought information on 1) I request you to please provide details of My Husband Mr Vijay Singh. Where is his Posting, Salary Slip. And they are in currently what position. As I already this details through Speed post dated 11/10/2019. But no reply is coming from your side. Not satisfied with the reply given by the CPIO, the Appellant has made her appeal on the grounds that CPIO has not provided the details.

I observe that CPIO has provided the factual position to Appellant. I find that CPIO has rightfully stated that the part of the requested information i.e. Salary Slip of Shri Vijay Şingh is exempted under section 8(1)(j) of the RTI Act. With respect to the salary details not available at the SIDBI website, CIPIO is directed to furnish the information within 20 working days.


