APPEAL NO. A-21/2019-20 BEFORE APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Ms Rinku Kanwar, 7/602, Royal Green Residency, Sirsi Road (Khatipura Sadak), Jhotwara – 302012, Rajasthan has preferred the present appeal dated February 10, 2020 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on February 10, 2020 against her RTI application dated January 07, 2020, requesting intervention of FAA in providing information sought by her in the RTI application.

Observations:

I have gone through the contents of her appeal dated February 10, 2020. It is observed that vide her RTI application dated January 07, 2020, the appellant has sought information on 1. What are the guidelines for securing loans taken under PMEGP Loan scheme in CGTMSE scheme. Appellant has made her appeal on the grounds that the query has been forwarded to the concerned Department, but she did not get any reply from them.

I observe that RTI application was transferred by CPIO to Credit Guarantee Fund Trust For Micro and Small Enterprises (CGTMSE), Mumbai on January 09, 2020, under section 6(3) of the Right to Information Act, 2005, since the information sought pertains to CGTMSE. A copy of the letter dated January 09, 2020 has been marked to the appellant also.
