APPEAL NO. A-22/2019-20 BEFORE APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Shri Chetan Prakash Pania, 1429(KHA), Outside Shitla Gate, Dharnidhar Maidan Road, Bikaner Pin-334001, Rajasthan has preferred the present appeal dated February 11, 2020 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on February 11, 2020 against the letter number 189992/RTI-5 /2836 dated February 06, 2020 passed by CPIO, requesting intervention of FAA in providing information sought by him in the RTI application.

Observations:

I have gone through the contents of his appeal dated February 11, 2020 as also the letter number 189992/ RTI-5 /2836 dated February 06, 2020 passed by CPIO in the matter. It is observed that vide his RTI application dated January 29, 2020, the appellant has sought information on 1) Detail and Name of SIDBIs MFIs or NGOs Partners under the PRAYAAS initiative, 2) Copy Hard Copy or Soft Copy in PDF of the MoUs or any agreement of SIDBI partnership with top 5 MFIs of NGOs which are providing microloan under Prayaas schemes, 3) Detail of the Guidelines or procedure of the SIDBI for providing loans to the micro entrepreneurs under the PRAYAAS initiative through its partners, 4) Detail of the loan disbursed state wise in this financial year 2019-2020, 5) Detail of the Percentage of NPA to total loan sanctioned state wise in this financial year 2019-2020. Not satisfied with the reply given by the CPIO, the Appellant has made his appeal on the grounds that details not provided.

I observe that CPIO has provided the factual position to Appellant. I find that CPIO has rightfully stated that the requested information at serial number 2 is exempted under section 8(1)(e) of the RTI Act.

The RTI mechanism is meant for providing available information which is not exempted under the provisions of RTI Act.

In view of the above, I do not find any infirmity in the order of the CPIO.

Order:

The appeal is accordingly disposed of. Copy of this order be sent to the appellant and CPIO.
