APPEAL NO. A-23/2019-20 BEFORE APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Shri Sunil Mishra, Kishreganj, Irgu Toli Road, Ranchi Pin-834002, Jharkhand has preferred the present appeal dated March 28, 2020 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on March 28, 2020 against the letter number 192408/ RTI-5 /2842 dated February 26, 2020 passed by CPIO, requesting intervention of FAA in providing information sought by him in the RTI application.

Observations:

I have gone through the contents of his appeal dated March 28, 2020 as also the letter number 192408/ RTI-5 /2842 dated February 26, 2020 passed by CPIO in the matter. It is observed that vide his RTI application dated February 12, 2020, the appellant has sought information on 1) What is the Credit Counsellor CCC scheme, 2) How many branch manager bank officers in Jharkhand are sensitized about the scheme give the details of all such officers if not why, 3) Define Clearly the role of NABARD DDM and LDM in sanction and promotion of CCC and portal, 4) How many branch managers are not aware of the guidelines and roles of CCC Credit counsellor and why give name and mobile number of branch manager, 5) How many branches have sanctioned the loan proposals assisted or guided by CCC Credit Counsellor give details of such branches, 6) How many branches have rejected the loan proposals assisted by CCC give details of branches and reason of rejection, 7) Is there any fund allocated by Government of India for promotion of this scheme if yes kindly give headwise details of all such allocated fund as well as the utilization and expenditure till date,

Now many awareness or sensitization camps organized for the GCG Entrepreneur todustry association CA etc if not give reason and if yes give the details of all such participants, 10) What is the stand up India scheme and how may loans sanctioned in Jharkhand and how many application rejected kindly clearly mention the reason of rejection, 11) Who are the authority who can generate the user id and password of the branches in Jharkhand give complete contact details of the authorized persons, 12) How many branches have been given user id and password till date give details of branches, 13) Why this delay in implementation of use of portal by branches, 14) What is udyamimitra in portal who has launched it and what is the purpose of launching this webportal, 15) How many loans sanctions and how many rejected through the online portal udyamimitra.in, 16) How many branches are regularly doing the log in on the webportal standupmitra.in and udyamimitra.in, 17) Any circular or guideline issued to the branch level functionary about the usage of standupmitra.in and udyamimitra.in portal if yes give copy of it and if not give reason, 18) Any circular or guideline issued by Ministry of Finance about the portal named www.standupmitra.in and www.udyamimitra.in portal kindly provide the copy as such, 19) Any circular or guideline issued by Department of financial services about the portal named www.standupmitra.in and www.udyamlmitra.in portal, kindly provide the copy as such, 20) Any circular or guideline issued by RBI or SLBC or SIDBI about the portal named www.standupmitra.in and www.udyamimitra.in portal kindly provide the copy as such.

Not satisfied with the reply given by the CPIO, the Appellant has made his appeal on the grounds that details not provided.
