

**APPEAL NO. 19/2018-19 BEFORE  
FIRST APPELLATE AUTHORITY UNDER  
RIGHT TO INFORMATION ACT (RTI ACT), 2005**

**Background:**

The Appellant, Shri Selvakumar, Plot number 2149, 11<sup>th</sup> Street, Mullai Nagar, Anna Nagar (West), Chennai-600040 has preferred the present appeal dated March 02, 2019 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on March 11, 2019 against the letter number L144252/RTI-5/2542 dated January 16, 2019 passed by CPIO, requesting intervention of FAA in providing information sought by him in the RTI application.

**Observations:**

I have gone through the contents of his appeal dated March 02, 2019 as also the letter no. number L144252/RTI-5/2542 dated January 16, 2019 passed by CPIO in the matter. It is observed that vide his RTI application dated December 15, 2018, the appellant has sought information on (1) Date of appointment and posts held by Thiru.E Ramesh Malavannan, GM from Manager, (2) Date of promotion in each cadre and Method of promotion either through Qualifying Written Examination /other mode of promotion adopted to give promotion to the official in each cadre, (3) Number of days of Medical/Sick Leave availed by the official from 01/04/2018 to 15/12/2018, (4) Whether the official's Medical / Sick Leave has been referred to medical board so far to verify genuineness of the official has applied medical leave more than 60 days during above period, (5) Whether the official is availing Medical Leave/Sick Leave to exhaust the medical leave available at credit or to supervise the construction work relating to the official's second house, (6) Whether the Medical Leave /Sick leave applied by the above official been sanctioned and claimed salary and disbursed to the official, (7) Whether the Banking Regulation Act permits the official to avail long leave in the cadre of GM, (8) Whether the official has produced registered construction

agreement showing ownership of house proving he is one of the owner at the time of applying home loan for second house, (9) Whether the official has mentioned in his home loan application about number of square feets to be constructed and produced any registered documents as proof for that, (10) Whether the official has intimated to bank about the impugned lock and seal, demolition notice issued by the Executive Engineer, Zone 7, Ambattur, Chennai 00053 Corporation of Chennai to stop the violated and deviated construction on 25/04/2017, (11) Whether the official has produced Completion Certificate issued by the competent authority Showing the completion of construction or intimated to bank about the construction has been stopped in response to demolltion notice issued against the deviated construction, (12) Whether the official has intimated to Bank that , he has been sanctioned a composite loan of Rs. 30 lakh in IDBI Bank, RAC, Nandanam, Chennai 600035 in addition to Rs. 10 lakh loan received from his brother in law for construction as well as own fund of Rs. 6.60 lakh(Total cost of the House is land cost Rs. 21.60 lakh and construction cost Rs. 22.50 lakh), (13) Why the official has unnecessarily obtained the loan for the purpose of second house from your bank at low interest and utilized the same for some other purpose, (14) Details of Audit objection, if any pending against the official from his entry of service to till date, (15) Details of Complaints received, disposed and pending against the official from his entry of service to till date.


Not satisfied with the reply given by the CPIO, the Appellant has made his appeal on the grounds that CPIO has not provided full details on his query.

I observe that CPIO has provided the information available on record. I did not find the information supplied by CPIO is incomplete. The RTI mechanism is meant for providing available information which is not exempted under the provisions of RTI Act.

In view of the above, I do not find any infirmity in the order of the CPIO.

**Order:**

The appeal is accordingly disposed of. Copy of this order be sent to the appellant and CPIO.
