APPEAL NO. 23/2018-19 BEFORE FIRST APPELLATE AUTHORITY UNDER RIGHT TO INFORMATION ACT (RTI ACT), 2005

Background:

The Appellant, Shri Vishal Thakkar, 605, Bluechip Complex, Near Vadodara Stock Exchange, Sayajigunj, Vadodara – 390005 has preferred the present appeal dated March 23, 2019 under section 19(1) of RTI Act and received by office of First Appellate Authority (FAA) on March 23, 2019 against the letter number L000150477/RTI-5/2578 dated February 28, 2019 passed by CPIO, requesting intervention of FAA in providing information sought by him in the RTI application.

Observations:

I have gone through the contents of his appeal dated March 23, 2019 as also the letter no. number L000150477/RTI-5/2578 dated February 28, 2019 passed by CPIO in the matter. It is observed that vide his RTI application dated February 05, 2019, the appellant has sought information on (1) How stock audit and concurrent audit allotments done and what criteria you consider while appointing auditor, (2) Please give details of NPA in FY 18-19 of Vadodara circle with accounts details with possible recovery of asset backing, (3) In information point 2 if loan given more than asset back give detail reason how loan given in such situation.

Not satisfied with the reply given by the CPIO, the Appellant has made his appeal on the grounds that CPIO has provided incomplete, misleading or false information. The appellant has indicated in his appeal dated March 23, 2019 that CPIO has informed 1) criteria for empanelment for stock audit and concurrent audit, no information how allotment made to empanelled person, who is appointing, name of person appointing authority, how they prefer between two similar empanelled person whom to work allot 2) Vadodara branch details not provided as asked in RTI request
