EDUCATIONAL QUALIFICATIOIN, WORK EXPERIENCE etc.

- > Demonstrated technical expertise in design, implementation of program of development nature with atleast 2 years' experience;
- > Applicant shall not be more than 30 years as on December 31, 2019;
- > Good experience in dealing with operational aspects related to microfinance/ livelihood/microenterprises aligned developmental activities;
- Excellent communication skills in English and Hindi, professional maturity and business judgment;

COMPENSATION

The compensation shall be Rs.50,000/- per month on CTC basis. However, a higher compensation would be considered for competent and experienced candidate based on their suitability/experience.

PERIOD OF CONTRACT

The term of the contract of Associate Manager - Financial Inclusion would initially be for a a period of 2 years. However, need-based renewal/extension of the contract may be considered by SIDBI subject to periodic review of performance.

GENERAL INFORMATION
