II. Terms of Reference (ToR)

Specification of the Videos as per following:

No. of Videos	1 introductory video introducing the Entrepreneurial Mascot Dhandebaaz
	 11 videos showing Dhandebaaz helping Entrepreneurs as per 11 Swavalamban issues.
Nature of the Video	Animated (2D)
Duration of Each Video	Upto 1-2 minute (Approximate). The duration of each video may vary and hence, the agency shall be required to furnish per-second cost in the commercial bid, which shall be multiplied by the duration of the approved (by SIDBI) video to arrive at the cost of the video at the time of raising invoice.
Audio Language of the Video	Bilingual (Hindi and English). For each video, 2 voice-overs i.e. in Hindi and English should be delivered. Hence in total, 24 videos shall be delivered.
Source of Content:	 As per Dhandebaaz comics published/ going to be published in 11 Swavalamban issues in Times of India Group & Hindustan Times (One India) Group. May be referred from: https://www.sidbi.in/en/swavlambans/meet-mr-dhandebaaz Audio script of video may be referred from above source and may be elaborated / explained. The audio script of the introductory/ other video should be drafted by the agency in such a way that interest to watch subsequent videos amongst the target audience is created. However, approval of audio script (Bilingual), Voice-Over and Completed Video should be obtained from SIDBI. Only approved videos by SIDBI shall be considered for payment.
Deliverable:	 High resolution video embedded with high resolution audio, as approved by SIDBI. SIDBI is not obliged to get all 12 Bilingual videos (i.e total 24) from the selected agency. Hence, the agency may start production of one video at a time and upon approval of the video by SIDBI, invoice for that particular video can be raised. Production of subsequent video may be started only after receiving confirmation from SIDBI.
Others:	 The agency should be ready to modify video/audio of the draft till the time final approval arrives. Any clarification required for developing the videos may be asked before/ during the pre-bid meeting, which would be clarified by SIDBI.



III. GENERAL TERMS & CONDITIONS

- 1. The quotation submitted by the bidder must be **strictly in the enclosed tabular format only with all heads duly filled in wherever applicable.** The quotation submitted in any other format other than the format given in **Section IV** may not be considered.
- 2. The commercial bid should be duly signed by authorised signatory with date and seal. Unsigned bids will be rejected.
- **3. Period of validity**: Price quoted by the agency must be valid till 90 days from the last date of submission without change in your proposed price. SIDBI will make its best efforts to select a vendor within this period. SIDBI may solicit bidder's consent to an extension of Proposal validity (but without any modification in the Proposal including proposed price).
- **4.** The price quoted must be inclusive of all taxes, levies etc. No additional cost whatsoever other than the price quoted by the vendor will be paid by SIDBI.
- **5. Opening and Evaluation of Bid:** The date/ time and place of opening of commercial bid would be on December 24, 2019 11:00 am at Small Industries Development Bank of India, Swavalamban Bhavan, 3rd Floor, Plot No. C-11, G Block, Bandra Kurla Complex, Bandra (E), Mumbai 400 051. It would be bidder's responsibility to depute the representative (one only) for the opening of bids. No separate communication in this regard shall be sent to the bidders.

The lowest quoted price (inclusive of all taxes) as per **Section-IV** will be termed as L1 bid and the rest of the bids shall be ranked in ascending order of price quoted, as L2, L3, L4 and so on. Order would be placed with commercially lowest quoting bidder i.e. L1 bidder.

6. Payment Terms:

- a) 100% payment on delivery of each animated video of Mr. Dhandebaaz (one at a time) upon approval by SIDBI and raising of invoice on SIDBI. Only approved videos by SIDBI shall be considered for payment.
- b) Invoice to be raised on each animated approved (by SIDBI) video of Mr. Dhandebaaz (one at a time), separately.
- c) SIDBI is not obliged to get all 12 Bilingual videos (i.e. total 24) from the selected agency. Hence, SIDBI shall not be responsible for making payments towards video (s), which is / are not approved by SIDBI. The agency, therefore, at its own interest, may start production of one video at a time and upon approval of the video by SIDBI, invoice for that particular video can be raised. Production of subsequent video(s) may be started only after receiving confirmation/go-ahead from SIDBI.
- d) Applicable taxes at source (TDS) will be deducted by SIDBI at the time of making payment.
- e) Payment shall be made electronically through RTGS/ NEFT by crediting the same to vendor's bank a/c as per details provided in the Bank Mandate Form.

1, 2: Note on IFSC / MICR

Indian Financial System Code (IFSC) is an alpha numeric code designed to uniquely identify the bank-branches in India. This is 11 digit code with first 4 characters representing the bank's code, the next character reserved as control character (presently 0 appears in the fifth position) and remaining 6 characters to identify the branch. The MICR code, (Magnetic Ink Character Recognition) that appears on cheques, has 9 digits to identify the bank-branch. RBI had since advised all the banks to print IFSC on cheque leaves issued to their customers. A customer may also contact his bank-branch and get the IFS Code of that branch.
