The TAG would constitute senior dignitaries from academia, regulatory bodies like AICTE, UGC, industry representatives and SIDBI officials. The agency would support SIDBI in constituting the TAG. The criteria for qualifying to be a part of the TAG would be devised by the agency in association with SIDBI. SIDBI would also provide letters of invitation to the TAG members mentioning their role in the process as every TAG member would have to obtain NOC from their respective institutes/ organizations to be a part of the TAG.	Clause stands modified as: The agency shall support SIDBI in constituting the TAG which shall comprise of senior dignitaries from academia, regulatory bodies like AICTE, UGC, industry representatives and SIDBI officials. The criteria for qualifying to be a part of the TAG would be devised by the agency in association with SIDBI. SIDBI would also provide letters of invitation to the TAG members mentioning their role in the process as every TAG member would have to obtain NOC from their respective institutes/ organizations to be a part of the TAG.

	To assist the selected professors/ academicians in publishing the finalized/approved caselets in reputed journals	with the quality will always remain a challenge. What needs to be understood is that, practically for publishing any article in a reputed, ranked journal (as mandated by the UGC) there is a huge turnaround time which is not even in control of the publishing house. There is generally a long queue for publication in top-ranked peer- reviewed journals. The time required may go even upto one year for publication. In such a situation, SIDBI may come out with its own publication (similar to MSME Pulse) and maintain its quality by keeping a proper editorial board, peer reviewers, etc. Through TAG, SIDBI can get its journal incorporated in the AICTE and UGC approved list of journals and also propose to put it as a reference in the curriculum as required. This is the only way that would ensure mass adoption of this journal by several institutions since they follow and are bound by the UGC and AICTE mandated curriculum.	The agency shall assist SIDBI through TAG in publishing at least 20 finalized / approved caselets in reputed journals & including the same in course curriculum through AICTE & UGC.
