ELIGIBILITY CRITERIA

1. The contractors should be preferably based at Odisha and having its/ their office at Bhubaneswar / Cuttack. They shall have minimum experience of 5 years in the field of executing similar works. Contractors who have executed similar work / empanelled with Banks, Financial institutions, central government/ state government, PWD and Public Sector Undertakings will be preferred.
2. The average annual financial turnover should be at least Rs. 200 lakh during last 03 years ending 31st March of previous financial year. (Audited Balance sheets showing turnover, Profit & Loss account of the firm for the preceding 03 years should be submitted)
3. The contractor should have satisfactorily executed works of similar nature of following magnitude in last 3 years (ending with the last date for receipt of applications).

Minimum qualification criteria for participating in the tender will be as follows:

- i. Experiences having successfully completed similar works during the last 3 years ending last day of month previous to the one in which tenders are invited should be either of the following:

a). Two similar completed works each costing not less than the amount equal to Rs 15 lakhs

OR

b). One similar completed work costing not less than the amount equal to Rs 24 lakhs

Details of work orders executed along with completion certificate from the client indicating value of work executed and performance shall be submitted in this regard.

4. The contractor should have a professional reputation and the quality of works executed by the contractor should be of acceptable standard. The works assigned to them should have been completed within the prescribed time.
