General Terms and Conditions for Supply, Installation, Testing and commissioning (SITC) of Vertical wall mounted Storage Electrical Water Heaters (Geysers for 15 nos. of Bank's residential Flats at 16MMM Marg, Lucknow-226001)

1. <u>Cost Details</u>:

The quoted price should include all levies / taxes like Service tax, Sales Tax, Transportation, Customs, Excise, travelling charges, support service during warranty, **Octroi** if applicable etc.

SIDBI will not be in a position to supply Form-C or Form-D and Agency will have to arrange for Form 31 or 32 or any other road permit, if required, on behalf of SIDBI.

2. Payment Terms and Security Deposit:

The standard payment terms of SIDBI are given below.

- i. Bidder shall deposit with the Bank by Demand Draft/Pay order/ bankers Cheque in favour of Small Industries Development Bank of India a sum of ₹ 14,000/- (Rupees Fourteen Thousand only)by way of Earnest Money Deposit (EMD) along with the tender. EMD of unsuccessful Bidders will be returned after execution of the contract agreement by successful bidder. This amount will not carry any interest. If the successful bidder fails to accept the LOI / sign the contract or do not provide the required performance security or expresses inability to carryout the contract or fails to start the work within stipulated time, the Bank shall forfeit the bid security amount (EMD) of the bidder and ban the contractor from subsequent bidding for a period of 3 years
- ii. In the case of successful Bidder the Earnest Money Deposit shall be held by the Bank for due fulfillment of the contract as initial security deposit. Initial security deposit will be 2 % of the accepted value of the bid (Including the amount of EMD). Also 8 % of the total value of work done will be withheld from the bill by the Bank as security deposit. The total security deposit shall be 8 % of the accepted contract value (including the Initial Security Deposit). This security deposit amount shall be released after satisfactory completion of one year of defects liability period without any interest. The defect liability period of one year

- will reckon from the date of handing over the Geysers after successful Supply, installation, Tesing and Commissioning.
- iii. 60% payment shall be made on supply (delivery) of geysers at Bank's flats at 16MMM Marg, Lucknow 226 001.
- iv. 32% Payment shall be made after Installation, Testing and Commisioning of Geysers at site.
- v. 8 % after successful completion of one year of defect Liability period and its certification by SIDBI representative.
- vi. All payments will be made by SIDBI, Lucknow through NEFT/ RTGS. The successful Bidder shall submit duly filled in Bank mandate form signed by the Bidder and countersigned by its Banker in the format supplied by SIDBI. Applicable TDS will be effected from payment.
- vii. Agency will be required to furnish the documentary proof of delivery, installation ,testing, commissioning, handing over the Geysers to SIDBI while claiming the payment.

3. <u>Terms of Delivery</u>:

All the Geysers shall be supplied, installed, tested and commissioned within <u>15 days</u> from the date of purchase order.

4. Insurance:

Geysers should be insured till commissioning and handing over to SIDBI.

5. Scope of Work, Installation & Acceptance:

- ✓ Delivery of Vertical wall mounted Storage Electrical Water Heaters (Geysers) confirming to specifications mentioned /agreed in Appendix to Annexure III,
- ✓ Fixing and Installations of the Electrical Water Heaters (Geysers) at desired locations of Kitchens and Toilets on all floors (8 floors) comprising 15 nos. of Residential flats at 16 MMM marg, Lucknow-226 001. Fixing and Installing at desired location with supply and fixing the accessories such as Anchor bolts, flexible reinforced hose pipe, connectors any modification / chiseling/plumbing etc. required for proper installation at desired

location and connection with Cold and Hot water inlet and outlet points, connection with Electric plug point including 15/20 Amp ISI marked 3 pin plug, etc. complete.

- ✓ Initial installation for one flat will be required to be executed as sample and on acceptance of the same with modifications, if any required /commented by SIDBI's representative, the balance work to be executed.
- ✓ Conduct test and checks and also demonstrate all the features of Electric Geyser to SIDBI representative. Rectify any Problem affecting the proper functioning of Electric Geyser/ commented by SIDBI representative. If particular unit does not function properly because of some Original Equipment Manufacturing defects, the same to be replaced immediately.

The Electric water Heaters (Geysers) will be deemed to be accepted only after these are supplied, installed, tested and commissioned as per SIDBI's requirement mentioned above.

6. On-site comprehensive warranty:

The OEM will give warranty/Guarantee for all the Electrical Water Heaters (Geysers) against defects arising out of faulty design, materials and media workmanship etc. complete for a period of 2 years or as per Original Equipment Manufacturing company policy from the <u>date of acceptance of the product</u>. In case of any problem during warranty/Gaurantee period the Bidder shall laison with the authorised service center of OEM based at Lucknow for rectification of the problems immediately.

7. Force Majeure:

If the performance as specified in this order is prevented, restricted, delayed or interfered by reason of Fire, explosion, cyclone, floods, War, revolution, acts of public enemies, blockage or embargo, Any law, order, proclamation, ordinance, demand or requirements of any Government or authority or representative of any such Government including restrict trade practices or regulations, Strikes, shutdowns or labour disputes which are not instigated for the purpose of avoiding obligations herein, or Any other circumstances beyond the control of the party affected, then notwithstanding anything here before contained, the party affected shall be excused from its performance to the extent such performance relates to prevention, restriction, delay or interference and provided the party so affected uses its best efforts to remove such cause of non-performance and when removed the party shall continue performance with utmost dispatch.

8. <u>Dispute Resolution:</u>

In the event of a dispute or difference or difference of any nature whatsoever between the agency and SIDBI during the course of the assignment arising as a result of this order, the same will be referred to The General Manager (Premises) and his decision in the matter will be binding on both the parties .

9. Indemnity:

The agency will indemnify SIDBI against any claims due to agency's violation of any statutory provisions in the format supplied by SIDBI as per Annexure V at the time of execution of Agreement for the contract.

10. **Damages to the Existing works / fittings** – No damages shall be caused to the existing work / fittings / fixtures during supply / installation and commissioning of Geysers. Agency shall be fully responsible for rectification of such damages.
