#### **GENERAL CONDITION OF THE CONTRACT**

#### 1. Scope of Work:

The scope of work includes supply, Installation, testing & commissioning of 23 no. of LED Television(21 nos - 32", 1 no.- 42", 1 no. 46") with remote control, complete in all respect as per specification & schedule of required quantities at Plot No. L-3, Jaydev Vihar, Opposite Loyala School, Bhubaneswar, Odisha. The vendor has to take care to wall-mount the sets. However provision for keeping the TV set on stand also should be provided

#### 2. Delivery:

- 1.1 Supply and installation of the items should be made within **30 days** from the date of the purchase/work order.
- 1.2 The contract is liable to be cancelled unilaterally if the supply/ installation is not completed within the specified time. Extension of contracted delivery period will be at the sole discretion of the Bank with applicability of liquidated damages clause. Decision of the Bank in this regard shall be final and binding on the successful tenderer.

#### 3. Penalty Clause:

1% per week subject to a maximum of 10% of the undelivered stocks will be recovered in case of delay in delivery beyond the accepted delivery period as per general conditions of contract. after which, Bank reserves the right to take action as deemed fit.

The Bank may extend the time of delivery & installation of the tendered items at their discretion on the application of the successful tenderer for such purpose provided that the Bank considers the reasons for such extension as good, sufficient and acceptable.

The decision of the Bank in this regard shall be final and binding on the successful tenderer.

#### 4. Earnest Money Deposit:

The bidders will be required to furnish bid security (EMD) of Rs. 20,000/-(Rupees Twenty Thousand only) in the form of Bank draft from any nationalized bank drawn in favor of Small Industries Development Bank of India. The bid shall be valid for a period of 90 days from the date of opening of bids. Offer not accompanied with earnest money of the requisite amount or without proper validity will be summarily rejected. The EMD is liable to be forfeited, if the tenderer winthdraws or amends or derogate from the tender in any respect within the period of validity of this tender.

#### 5. Validity of Offer:

The tenderer must keep their offer open for acceptance for a minimum period of 90 days from the date of opening of tender.

#### 6. Terms of Payment:

No advance payment shall be made by the Bank on any circumstances. 100% payment of the cost will be paid on satisfactory supply & installation of works after inspection. Bill in this regard duly supported with the inspection by the above document should be submitted to the Bank and particulars of dispatch advised to the consignee. Payment shall be released within 30 (thirty) working days from the date of receipt of invoice/bill duly accompanied by receipted challan.

#### 7.Warranty:

Manufacturers' standard comprehensive on-site warranty for the tendered items as per enclosed specifications shall be offered effective from the date of supply & installation of the equipments [Warranty Certificate on paper (not by any electronic form) duly signed and sealed by the Manufacturer need to be submitted by the successful tenderer]. The successful tenderer shall be responsible for all defects/inferior quality of materials etc. for the entire warranty period of the equipment, which will be finally installed at SIDBI, Training Institute.

#### 8. Facilities for Test & Examination:

If the TVsets supplied by the manufacturer/ supplier or performance of the material and/ or stores during inspection and tests is not found satisfactory, the Bank reserves the right at his discretion and without any claim for compensation to the Contractor, either cancell the order altogether or modify the quantity ordered.

#### 9. Arbitration

All disputes and differences between the successful tenderer and the Bank of any kind except quality of workmanship and materials whatever arising out of or in connection with the order on carrying out the supply (whether during the progress of the work or after their completion and whether before or after the determination, abandonment or breach of the terms & conditions of the order) shall be referred to the sole arbitration of a person nominated by the Director, SITI, whose decision in this regard will be final and binding on the both successful tenderer and the Bank.

The provision of the Arbitration and conciliation act 1996 or any statutory modification or re-enactment thereof and of the rules made there under for the time being in force shall apply to arbitration proceedings under this clause.

#### 10. Price:

The price and rates indicated/quoted shall be inclusive of cost of materials, supply and all incidental charges to supply and install the LED TELEVISION strictly as per Bank's specification (enclosed) at SIDBI's Premises at Plot No. L-3, Jaydev Vihar, Opposite Loyala School, Bhubaneswar, Odisha. The price quoted by the bidder shall be firm and not subject to variation on any account during the fulfillment of the order. The price quoted shall also be including all taxes and duties e.g. Excise Duty, CST, and VAT etc. and any other Govt. levy as applicable, cartage, labour and nothing shall be paid extra on this account. All the rates mentioned in the tender should be inclusive of all materials including wastage, freight, all types of taxes including works contract tax, duties, octroi, service tax, royalties, tools, tackles, plant and equipments, supervision,

overheads and profits, statutory charges, costs for licenses / liaisoning and any other expenditure etc. and shall remain firm till completion of work. Escalation in price will not be payable for whatsoever reasons.

- **11. Evaluation Period/Process:** The broad guidelines for evaluation of offer will be as follows:
- 11.1. Only those offers shall be evaluated which are found to be fulfilling all the eligibility and qualifying requirement of the tender both technically and financially.
- 11.2. SIDBI shall evaluate the bids to determine whether they are complete, whether any computational errors have been made, whether the documents have been properly signed and whether the bids are generally in order.
- 11.3. Arithmetical errors shall be rectified on the following basis. If there is a discrepancy between the unit price and total price that is obtained by multiplying the unit price and quantity, the unit price will prevail and the total price shall be corrected by the SIDBI. If there is a discrepancy between words and figures, the amount in words shall prevail. If the supplier does not accept the correction of errors, his bid shall be rejected. No overwriting or cutting is allowed.

The lowest acceptable tender shall be considered further for placement of contract/supply order after complete clarification and price negotiations as applicable.

The Lowest price will be calculated taking all the 23no. of units of a single brand together.

#### SAFETY CONDITIONS OF THE CONTRACT:

As part of the contract, the contractor must satisfy the under mentioned safety requirements and must ensure at all item that these are followed without any deviation.

- 1. The contract shall take all precautions to avoid accident and causes of accident. He must be careful regarding safety during working of his staff in the premises.
- 2. Safety precautions of portable electrical appliances: Precaution in handling portable electrical appliances are more significant under monsoon conditions, some likely situations are highlighted here for your attention and action to ensure that conditions and methods of usage conform to the safety of personnel and property.
- I) Broken sockets/ pin plug/ loose connections: These conditions cause sparks which lead to fault conditions or electrical shock situations. Wires shall not be directly inserted into the sockets as the earth lead of the equipment inserted into the phase socket may give shock to the operator.
- li) Polarity of phase/ neutral and earth: certain appliances like Poroscope may give violent electrical shock during work if polarity conditions are not satisfied.
- lii) Joints in flexible cables: Usage of portable appliances is such that electrical and physical integrity of joint may be suddenly affected, leading to severe sparking and fire if combustible/ inflammable materials are present near the joint. Perhaps this may not be noticed by operator at all.
- iv) Appliance body grounding and system grounding: In absence of or ineffective appliance body grounding, operator may receive severe shock in case of phase to earth fault during usage. And also, all earth pins in sockets must have low impedance and mechanically firm earthling according to Indian Electricity Rule so that safety is assured to operator even under fault conditions.
