Bids are invited for services to be engaged for Annual Maintenance Contract for General Maintenance, housekeeping of SIDBI Officers Residential flats at (i) 16 MMM Marg Lucknow and (ii) Arif Kings Apartment, Mall Avenue, Lucknow.

The bidders are requested to submit their quotation in the attached format in Tender Document comprising:

**All the intending Agencies/Contractors are also
requested to note following important provisions.**

1. SIDBI is governed by Public Procurement Policy for Micro and Small Enterprises (MSEs) as circulated by The Ministry of MSME, Gol.
2. These provisions shall be applicable to Micro and Small Enterprises (MSEs) registered with District Industries Centers or Khadi and Village Industries Commission or Khadi and Village Industries Board or Coir Board or National Small Industries Corporation or Directorate of Handicrafts and Handloom or any other body specified by Ministry of Micro, Small and Medium Enterprises (MSMEs).
3. If deemed fit, the Bank may procure minimum of 20% of the contract value of any goods or services from MSEs. Further, the Bank reserves the right to procure part work/services (about 4% out of above 20%) to MSEs owned by SC and ST entrepreneurs, if found suitable. Provided, these MSEs quoting price within the price band of L1 +15% & bringing down their price to L1 price, in a situation where L1 price is from someone other than a MSEs. In case of more than one such MSEs, the supply shall be shared proportionately at the discretion of the Bank.

Applications are invited from experienced and competent contractors (Lucknow based / having registered branch office at Lucknow) for taking up the Annual Maintenance Contract for General Maintenance, House Keeping and of SIDBI Officers Residential flats at (i) SIDBI Officers Apartment, 16, MMM Marg, Lucknow, (ii) SIDBI Officers Apartment, Wing B, Arif Kings Apartment, Mall Avenue, Lucknow, subject to fulfilling following eligibility criteria :

Minimum qualifying criteria :-

1. Contractor should have minimum 5 years of experience in the field.
2. Contractor should have done at least one job of similar nature & magnitude in the last 3 years – Annual Maintenance, General Building Maintenance premises (one or more) of Ground plus 8 floors Residential building one such AMC work costing minimum `18.50 lakh per annum or two such works costing minimum Rs.11.50 lakh to be eligible.
3. The contractor should be an income tax assessee and should have filed Income Tax return for the last 3 assessment years.
Contractor to be in profit, at least in one financial year during the last three financial years.
Annual gross income reflected in any one of the three financial years shall be taxable.
4. The contractor should have valid GST Registration, Registration with labor department, P.F. and ESI registration.
5. The contractor could be a sole proprietary concern / partnership firm or a company and should be registered with Registrar of Firms / Companies wherever applicable.
6. Contractor should have sufficient and competent manpower and tools & tackles to take up the work.
7. Contractor should not have been black listed by any Central / State Government / Public Sector Undertaking / Institute of Govt. of India.
8. Bank reserves the right to verify the credibility of contractor from references mentioned by the contractor in Sl. No.13 of application format of Technical Bid. In case of getting the negative feedback, Bank reserves the right to disqualify the contractor.
9. Should have solvency of amount Rs.15 lakh to judge about the financial soundness of the contractor to execute the work. This will be judged as per attached Solvency certificate from the Bankers or Income tax return filing attached by the contractor.

In case the contractor qualifies the above criteria his price bid will be opened.

General Terms and Conditions

Period of Contract

The contract shall be valid for a period of **24 months** commencing from the date of award of contract. However, Bank reserves its right to review and terminate the same before completion of the said period. **The contract shall remain effective normally for two year. However, SIDBI reserves the right to renew the contract after completion of 1st year (i.e.,12 months) year as per prevailing minimum wages as per Ministry of Labour & Employment , Office of Chief Labour Commissioner, N. Delhi and depending on satisfactory performance of the contractor.**

Performance Guarantee

(1) Earnest Money Deposit (EMD) for the work at SIDBI Tower is `33,000/- (Rupees Thirty Three Thousand Only).

(2) The EMD of successful contractor shall be returned on submission of security deposit as Bank Guarantee as follows. The security deposit equivalent to 6% of contract value (including EMD) , the Bank Guarantee (BG) shall be 6% of contract value per year as security deposit. No charges shall be payable on this account. The Bank Guarantee(BG) should be in the format approved by the Bank and should be kept valid for a period of 24 months with a claim period of 6 months.

No payment shall be released till the BG is submitted.

The Bank Guarantee (BG) shall be encashed in case the contractor fails to perform his duties satisfactorily.

- Successful bidder shall deposit a security deposit equivalent to 6% of contract value (including EMD) in the form of BG drawn in favour of Small Industries Development Bank of India payable at Lucknow within a week from the date of issue of work order. The deposit will not carry any interest and will be refunded after completion of the contract. In the event of breach of contract by the contractor, the security deposit will be forfeited.
- The maintenance charges shall be paid to the contractor after the end of each month. The contractor shall submit detailed (with break of payment made to his employees) monthly bill along with a certificate from the Care Taker / concerned officer indicating that the whole work is carried out satisfactorily. Applicable taxes will be deducted at source. A copy of attendance register of workers, receipt of payment made to the workers (cheque / RTGS payments) shall be provided with the monthly bills. If observed that the payments being made are not as per labor law, Bank reserves the right to deduct required amount found eligible to be paid to the worker and pay the same directly to the worker. In that case bank

may also impose suitable penalty on the contractor for noncompliance of labor law. SIDBI has the right to insist that the payment to the workers be made in presence of Bank's nominee.

- Contractor shall provide receipt of deposition of PF, ESI etc. of workers from concerned department along with the monthly bill.
- The Material rate quoted by the contractor shall be remain unchanged for the entire period of the contract, however manpower wages would be paid on actual labour deployed at site as per the prevailing minimum wages as per Ministry of Labour & Employment , Office of Chief Labour Commissioner, N. Delhi.
- The rates quoted shall include cost of all tools & tackle, manpower cost including wages (including P.F., ESI contribution Employee and Employer), liveries etc. taxes & duties (including applicable taxes such as GST etc.) insurance (if any) etc. payable to the appropriate authority. No extra payment over and above the rate quoted shall be made to the contractor in this respect.

Insurance

- I. The Contractor shall keep the employer, its servants or agents indemnified against claims, actions or proceedings brought or instituted against the employer, its servants or agents by any of contractors' employees or any other third party in connection with relating to or arising out of the performance of the services under the agreement. The contractor is also required to obtain the third party insurance for each incident as follows:-
 - a. Personal injury - ` 3.00 lacs
 - b. Property Damage - ` 3.00 lacs
- II. Besides covering all employees of contractor under ESIC scheme, the contractor shall also require to obtain a workman compensation policy for an amount atleast ` 2 Lacs per employee and covering all the staff during the contract period deployed at site. If contractor fails to comply with the above provisions, SIDBI reserves its right to deduct suitable amount from the contractors payment and pay the insurance company.
- III. The Bank shall not be bound to accept the lowest tender and reserves the right to reject any or all the tenders without assigning any reasons thereof.
- IV. If Bank decides to place work order for additional scope of work in the same premises or amend the original contract for additional scope of work in the same premises, the contractor shall be bound

to accept the same at rates contained in the original work during the currency of the contract.

- V. Tenderer shall quote his rates and submit break-up thereof for all items of work described in the price bid

Termination of Contract

If the contractor fails to perform any of the obligations under this contract and if the Bank is dissatisfied with the services, the Bank may terminate the services of the contractor with a notice of winding up and the contractor shall vacate the premises within a period of one month of written notice. Bank should not be held liable for any cost, damage, expenses or any loss whatsoever that the contractor may suffer on being served with the winding up notice and termination of contract. However, the contractor is required to give 3 month's notice in case he does not want to continue the contract. In this case, Bank shall forfeit the security deposit and shall award the contract to new agency.

- The contractor should comply with the requirements of latest Labor Acts and Minimum Wages Act 1948 and its latest amendment including taking necessary insurance cover for its staff, if required, minimum wages of labor to be paid as per the approved latest applicable central minimum wages.
- **The contractor is required to obtain and submit police verification report of his staff employed within one month from the award of contract at his own cost. Else, SIDBI reserves the right to withheld the payments and no plea in this regard shall be entertained.**
- The contractor shall be solely responsible for all injury to the workmen and for all damages caused to the building, DG set and other properties that may occur due to negligence, carelessness, accidental or any other reasons whatsoever. The contractor shall fully indemnify SIDBI and hold SIDBI harmless in respect of all and any such expenses arising from all such injury or damages to any person(s) or property as aforesaid and also in respect of any claim made in respect of injury or damage under any act of compensation or damage consequent upon such claim.
- Before quoting, the bidder may visit the site and make himself familiar with the site, nature and conditions of work involved.
- In case unsatisfactory service, SIDBI reserves the right to terminate the contract by giving 30 days notice and forfeit the security deposit. Decision of SIDBI in such matters shall be final and cannot be challenged.
- The contractor or his authorized representative shall be present at site every day and closely supervise / monitor the entire work entrusted to him and report the progress of work / repair etc. that needs to be taken up, to the caretaker / concerned officer regularly.
- The successful bidder shall be required to give an undertaking with the monthly bills in the enclosed format that he is making regular payments

to his employees as per the minimum wages Act, ESI, EPF Act and complies all other applicable labor laws / statutes.

- The contractor is required to carry out additional minor repair / replacement works. No labor payment for the same shall be made as it is deemed to be included in the quoted cost. The material charges, if any, shall be paid to the contractor on reimbursement basis subject to production of pucca bills / cash memos and after verification from market. Contactor to take up such works only after obtaining due approval of authorized officials of premises vertical, SIDBI. SIDBI's decision in all such matters shall be final and binding on the contractor.
- The works such as dusting, cleaning, mopping, toilet cleaning, spray of room freshener etc should be completed daily latest by 09.15 a.m.
- The contractor is required to provide a mobile phone to his site supervisor (at least 1 no.) so as to contact him as and when needed. Else penalty of Rs.1000/- per month would be applicable.
- The man power deployed should be well experienced. If the same is not found satisfactory, Bank can ask for their replacement without any obligations.
- All workers should be provided with uniform and they should be all the time in uniform while in office premises.

Penalty clause:

The penalty will be imposed in the form of deduction of ` 1,000/- per day in case of absence of any of the Cleaning / Technical staff member or Gardener /unsatisfactory work as may be found at site or may be brought to the notice of Caretaker. Supervisor will have to sign the register & ascertain the No. of staff present on particular day. The register will be kept with the Guard at all the Premises & entry shall be made in the presence of Guard on Duty.

Compensation towards non-attentiveness

Contractor shall maintain a proper Record / Register indicating reasons for not attending to any particular complaint within time schedule, failing which appropriate compensation shall be recovered. The expected period of completion of the various items and the amount of deduction beyond that period for pending complaints will be as in the next page :-

ARTICLE OF AGREEMENT made at Lucknow on this __ day of __ 2018 between Small Industries Development Bank of India, a corporation established under the Small Industries Development Bank of India Act, 1989 (39 of 1989) and having its Head Office at 15, Ashok Marg, Lucknow (hereinafter called the Bank) of One Part And " _____" a ___ within the meaning of the ___ and having its Registered Office at _____ [hereinafter called the Maintenance & Housekeeping Services (CONTRACTOR)], the Other Part / Second Part.

Whereas the Bank is desirous of awarding the job of manning, housekeeping maintenance of various utility services for the Bank's residential apartments in LUCKNOW at _____. (hereinafter referred to as the premises and more precisely described in the Tender Documents) under Maintenance & Housekeeping Services (CONTRACTOR) Contract. The services include cleaning, maintenance and repairs of civil, plumbing, carpentry etc. and any other similar systems and services for the Bank's quarters. The details of services and scope of work / services are given in Tender Document and Addendum which forms part of the Agreement and the Tender Document and Addendum for the sake of brevity will be referred to as the " Contract Document " in these presents.

Whereas the said contract was awarded to the Contractor vide Bank's letter No. _____ dated _____, 2018 which was duly accepted by the contractor on ____, 2018 (hereinafter referred to as the 'offer letter'). Whereas as per the offer letter, Contractor is required to execute an agreement with the Bank and to reduce the terms and conditions as agreed upon into writing through these presents.

NOW IT IS HEREBY AGREED AS FOLLOWS:-

1. For the consideration hereinafter mentioned, the Contractor will hereby agree upon and subject to the terms and conditions contained therein, carry out all the work and render the services, as indicated in Annexure and more particularly described in contract document at all the designated places.

2 a) The Bank after satisfaction of the services rendered by the Contractor, will pay to the contractor contract amount of ` _____ (Rupees _____ only)) per year (hereinafter referred to "the Contract Sum"), details of which are given at Annexure II or such other sum as shall become payable hereunder on monthly basis after completion of each month and submission of bill thereof after performing all the work in pursuance of the Contract Document and to the satisfaction of the Bank.

b) The GST is included in the contract amount and Contractor will pay Tax directly to the concerned authority and produce its necessary proof, if demanded by the Bank.

3. The Contractor shall arrange every reasonable facility and carry out all works relating to the maintenance of various services in the manner laid in the contract documents till the completion of the contract.

4. This contract is neither a fixed Lump Sum contract nor a Piece work contract. But is a contract for manning, housekeeping and maintenance of the Office premises and its services / facilities and to be paid for proportionately according to the actual service performed.
5. The Bank reserves to itself the right of altering the scope of work and nature of the work by adding to or omitting any items of work or having portion of the same carried out through other agency without prejudice to this contract. The contractor will only be paid for the actual service performed and work done payable at the accepted unit rates.
6. The parties hereto shall abide by, submit themselves to the conditions and perform the task as per the agreement on their parts respectively in such conditions contained.
7. This agreement and the documents mentioned herein shall form the basis of the contract. The provisions contained herein shall be read in conjunction with the provisions of the said documents.
8. The Contractor hereby agree and declare that
 - a) his quoted cost / rates as indicated above includes day to day repairs / replacement of plumbing, sanitary, carpentry fittings, etc. as detailed out in the contract document and shall be inclusive of all labour and material including all duties, royalties GST or any other taxes or local charges. No extra claim on this account will be entertained. However, Labour charges for major repairs (beyond scope of work) will be paid extra to the Contractor as explained in the tender.
 - b) Register for weekly/regular visits of carpenter. plumber to the office premises shall be maintained at main gate or at the appropriate places as decided from time to time by the Bank. All complaints recorded in the register shall be attended promptly by the contractor.
 - c) It shall not demand any conveyance charges from the Bank for performing the work as per the terms and conditions of the contract.
 - d) The contractor shall liaison with the municipal / statutory authorities for compliance of statutory requirements and produce all the relevant statutory documents for inspection by the Bank and Government Authorities.
9. If the Bank is not satisfied for the services rendered by the contractor, recovery will be made by the Bank for not carrying out the job stipulated within reasonable period as per the terms and conditions of the contract document.
10. The contractor, as per the terms of the contract, agrees and declares that number of full time / part time skilled / unskilled workers to be employed by the contractor shall be strictly adhered to so as to perform the work satisfactorily during the entire period of the contract. In case, additional resources are required for satisfactory performance of the job, the same shall be employed by the Contractor at its own cost and no additional payment shall be made by the Bank.
11. Both parties hereby agree that timely performance of the contractual obligation shall be considered as the essence of the contract and the

contractor hereby agrees to perform the job to the satisfaction of the Bank during the stipulated contract period within reasonable time.

12. All payments by the Bank under this contract will be processed only at Lucknow in Indian Rupees and shall be within 15 working days from the submission of bills including period of checking subject to bill being in complete shape as described in the contract document and format to be mutually agreed.

13. That the several parts of the contract documents have been read by the contractor and fully understood by him/them. The contractor shall not be entitled for the payments for any extra major work done beyond the contract unless ordered for, by specific instructions with prior approval from the Bank.

14. This contract shall be initially for a period of 2 years from the date of commencement of the work i.e. _____, 2018 and The Material rate quoted by the contractor shall be remain unchanged for the entire period of the contract, however manpower wages would be paid on actual labour deployed at site as per the prevailing minimum wages as per Ministry of Labour & Employment, Office of Chief Labour Commissioner, N. Delhi.

The contract can be extended further, if need be on the mutually agreed terms. If the Contractor fail to perform any of its obligations under this agreement and if the Bank is dissatisfied with the services of the Contractor during the regular and / or extended period, the services of the Contractor will be terminated by the Bank after giving a notice period of one month and the Bank shall have right to encash the Bank Guarantee submitted as Security Deposit. The Bank shall not be liable for any cost, damage, expenses or any loss whatsoever that Contractor may suffer due to termination of the contract. In case Contractor do not want to continue with the contract, he may terminate the contract by giving 3 months notice to the Bank and he shall continue to perform his duties during notice period or till alternate arrangement is made by the Bank, whichever is earlier. Under such situations, the Bank shall have right to forfeit the security deposit by encashment of the Bank Guarantee and to award the contract to new agency.

15. During the currency of the contract, it shall be the responsibility of the contractor to keep all their labour /staff insured for the amount indicated in the tender as well as to comply all the provisions of prevailing labour legislation and all other relevant Acts for minimum wages, health facilities, Provident Fund, ESIC etc. and the Bank will not be liable or responsible for any damages, claim, charges whatsoever demanded by any Authorities / Forum for Servants or Agent of the Contractor for any wrongful act or omission not complying the statutory requirement or for any matter connected therewith. In case any claim is received by the Bank on this account, the contractor shall indemnify the Bank for the same.

16. In case, contractor do not carry out any items of work or any work carried out by the contractor, is not satisfactory, the Bank will have right to get this work executed by other agency at the risk and cost of contractor and the expenses shall be adjusted from the contractor's bill.

17A. The Contractor shall maintain a proper record / register indicating reason for not attending to any particular complaint within time schedule and also for non-completion of routine activities, failing which appropriate compensation as indicated in contract document shall be recovered.

17B. All the works shall be carried out as per the prevailing practices and by using best quality materials as indicated in tender or instructed by the Bank. The contractor shall be wholly responsible for the damages to the property of Bank / occupants due to improper practices or carelessness, etc.. In such cases, Bank reserves the right to recover appropriate compensation.

18. The contractor cannot sublet the work without the prior permission of the Bank. However, he may be required to depute specialised agencies for a particular work, approval of which may be sought from the Bank before appointing. It shall be entirely contractor's responsibility to pay timely such agencies without any implication on the work.

19. Conduct of its worker

The contractor and his workers shall maintain necessary decorum / discipline while carrying out the work. Any indecent behavior shall not be tolerated and stern action for the same shall be initiated against the contractor / his staff.

20. All disputes and differences of any kind whatsoever arising out of or in connection with the contract whether during or after completion of contract shall be deemed to have arisen at Lucknow and only court in Lucknow shall have jurisdiction to determine the same.

NOW, THEREFORE,

To avoid all forms of corruption by following a system that is fair, transparent and free from any influence /prejudiced dealing prior to, during and subsequent to the currency of the contract to be entered into with a view to :-

Enabling the BUYER to obtain the desired said services/stores/equipment at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement and

Enabling BIDDERS to abstain from bribing or indulging in any corrupt practice in order to secure the contract by providing assurance to them that their competitors will also abstain from bribing and other corrupt practices and the BUYER will commit to prevent corruption in any form by its officials by following transparent procedures.

The parties hereto hereby agree to enter into this integrity Pact and agree as follows:

Commitments of the BUYER

- 1.1. - (i) Bank Draft on a Pay Order in favour of Small Industries Development Bank of India.
- (ii) A confirmed guarantee by an Indian Nationalised Bank, promising payment of the guaranteed sum to the BUYER immediately on demand without any demur whatsoever and without seeking any reasons whatsoever. The demand for payment by the BUYER shall be treated as conclusive proof of payment.
- (iii) Any other mode or through any other instrument (as specified in the RFP)

5.2. The Earnest Money/Security Deposit shall be valid for a period of 24 months with a claim period of 6 months to the complete satisfaction of both the buyer and bidder, including the warranty period, whichever is later.

5.3. In case of the successful BIDDER a clause would also be incorporated in the Article pertaining to Performance Bond in the Purchase Contract that the provision of Sanctions for Violation shall be applicable for forfeiture of Performance Bond in case of a decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.

5.4. No interest shall be payable by the BUYER to the BIDDER on Earnest Money/Security Deposit for the period of its currency.

6. Sanctions for Violations

6.1. Any breach of the aforesaid provision by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER) shall entitle the BUYER to take all or any one of the following actions, wherever required :-

- (i) To immediately call off the pre contract negotiations without assigning any reason or giving any compensation to the BIDDER. However, the proceedings with other BIDDER(s) would continue
- (ii) The Earnest Money Deposit (in pre-contract stage) and /or Security Deposit/Performance Bond) (after the contract is signed) shall stand forfeited either fully or partially, as decided by the BUYER and the BUYER shall not be required to assign any reason therefore.
- (iii) To immediately cancel the contract, if already signed, without giving any compensation to the BIDDER
- (iv) To recover all sums already paid by the BUYER, and in case of Indian BIDDER with interest thereon at 2% higher than the

prevailing Prime Lending Rate of State Bank of India, while in case of a bidder from a country other than India with interest thereon at 2% higher than LIBOR. If any outstanding payment is due to the bidder from the buyer in connection with any other contract for any other stores, such outstanding payment could also be utilized to recover the aforesaid sum and interest.

- (v) To encash the advance bank guarantee and performance bond/warranty bond, if furnished by the BIDDER, in order to recover the payments, already made by the BUYER alongwith interest.
- (vi) To cancel all or any other Contracts with the BIDDER, the BIDDER shall be liable to pay compensation for any loss or damage to the BUYER resulting from such cancellation/rescission and the BUYER shall be entitled to deduct the amount so payable from the money(s) due to the BIDDER.
- (vii) To debar the BIDDER from participating in future bidding processes of the buyer or its associates or subsidiaries for minimum period of five years, which may be further extended at the discretion of the BUYER.
- (viii) To recover all sums paid in violation of this Pact by BIDDER(s) to any middleman or agent or broker with a view to securing the contract.
- (ix) In cases where irrevocable Letters of Credit have been received in respect of any contract signed by the BUYER with BIDDER, the same shall not be opened.
- (x) Forfeiture of Performance Bond in case of decision by the BUYER to forfeit the same without assigning any reason for imposing sanction for violation of this Pact.

6.2. The BUYER will be entitled to take all or any of the actions mentioned at para 6.1(i) to (x) of this Pact also on the commission by the BIDDER or any one employed by it or acting on its behalf (whether with or without the knowledge of the BIDDER), of an offence as defined in Chapter IX of the Indian Penal code, 1860 or Prevention of Corruption Act, 1988 or any other statute enacted for prevention of corruption.

6.3. The decision of the BUYER to the effect that a breach of the provision of this Pact has been committed by the BIDDER shall be final and conclusive on the BIDDER. However, the BIDDER can approach the independent Monitor(s) appointed for the purposes of this Pact.

7. Fall Clause

7.1. The BIDDER undertakes that it has not supplied/is not supplying similar products /systems or subsystems or providing similar services at a price lower than that offered in the present bid in respect of any other Ministry/Department of the Government of India or PSU and

if it is found at any stage that similar product/systems or sub systems was supplied or similar services provided by the BIDDER to any other Ministry/Department of the Government of India or a PSU at a lower price, then that very price, with due allowance for elapsed time, will be applicable to the present case and the difference in the cost would be refunded by the BIDDER to the BUYER, if the contract has already been concluded.

8. Independent Monitors

- 8.1** The BUYER has appointed Independent Monitors (hereinafter referred to as Monitors) for this Pact in consultation with the Central Vigilance Commission. Please refer to tender document for details.
- 8.2** The task of the Monitors shall be to review independently and objectively, whether and to what extent the parties comply with obligations under this pact.
- 8.3.** The Monitors shall not be subject to instruction by the representatives of the parties and perform their functions neutrally and independently.
- 8.4.** Both the parties accept that the Monitors have the right to access all the documents relating to the project/procurement, including minutes of meetings.
- 8.5.** As soon as the Monitor notices or has reason to believe, a violation of the Pact, he will so inform the Authority designated by the BUYER
- 8.6.** The BIDDER(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the BUYER including that provided by the BIDDER. The BIDDER will also grant the Monitor, upon his request and demonstration of a valid interest, unrestricted and unconditional access to his project documents. The same is applicable to Subcontractors. The Monitor shall be under contractual obligation to treat the information and documents of the BIDDER/Subcontractor(s) with confidentiality
- 8.7.** The BUYER will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the parties. The parties will offer to the Monitor the option to participate in such meetings
- 8.8** The Monitor will submit a written report to the designed Authority of the BUYER within 8 to 10 weeks from the date of reference or intimation to him by the BUYER/BIDDER and should the occasion arise, submit proposals for correcting problematic situations.

9. Facilitation of Investigation

In case of any allegation of violation of any provision of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the BIDDER and the BIDDER shall provide necessary information and documents in English and shall extend all possible help for the purpose of such examination. A person signing integrity pact shall not approach the courts while representing the matters to IEM and he/she will wait their/his decision in the matter.

10. Law and Place of Jurisdiction

This Pact is subject to Indian Law. The place of performance and jurisdiction is the seat of the BUYER

11. Other Legal Actions

The action stipulated in this integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

12. Validity

12.1. The validity of this Integrity Pact shall be from date of its signing and extend upto 5 years or the complete execution of the contract to the satisfaction of both the BUYER and the BIDDER/Seller, including warranty period, whichever is later in case BIDDER is unsuccessful, this integrity Pact shall expire after six months from the date of the signing of the contract.

12.2. Should one or several provisions of the Pact turn out to be invalid, the remainder of this Pact shall remain valid. In this case, the parties will strive to come to an agreement to their original intentions.

13. This pact shall be deemed as part of the contract that may be entered into pursuant to this RfP. The parties hereby sign this integrity Pact, at _____ on ____

SCOPE OF WORK

AREA TO BE MAINTAINED

The common area including staircase, lobbies, utility rooms, compound, BMO Room, Gym area and common washroom, terrace, garden, building premises etc. & the entire building are being considered for comprehensive maintenance and housekeeping works.

THE SERVICES COVERED ARE

- House Keeping & Maintenance Coordination
- Engineering
- Gardening / Horticulture

Upkeep

Working Days : Monday to Saturday, both Days inclusive.

Working Hours : As specified in manpower details

1. Electrical Systems

1.1. Periodical Checks of LT Panel

- Check the incoming voltage.
- Check the individual feeder voltage wherever possible.
- Check for abnormal heating, for loose connections at terminations, MCBs and change over switches.
- Check cleanliness of LT panel room.
- Check for all visual indications
- Check for any abnormal noise in all the panels.
- Check all earth pits physically and take earth resistance reading once a quarter.
- Ensure that the load current is within safe value based on actual load.
- Check all cable terminations and tighten the connections if required.
- Check the feeders for operation.
- Draw-out all circuit breakers and tighten the connection and lubricate the rail mechanism and moving contacts.
- Check all connections against loose contact.
- Check for any loose crimping and cable heating.
- Check for proper insulation and earthing too.

1.2. Electrical Installation:

- Operation and maintenance of the Electrical Equipment in accordance with the Manufacturer's Instruction Manual.
- Check Battery Back up time once in a month.
- Check of all safety controls and Electric Switch Gears – Condition of Contractor fingers, oiling of pivots, tightening of connections to prevent sparking etc.
- Regular cleaning of pumps – Inspect Terminals & Clean, Check correctness of Readings
- Check Voltage, Current, Frequency in each LT Panel
- Check all the Cables, Bus Bars, Nut-Bolts, Insulation etc. for the Panels
- Replacement of faulty lights and fixtures on reimbursement basis.
- Carry out PM as per the annual PM Chart, which would be created by Bidder.

1.3. Fittings and Fixtures

- Check all fittings and fixtures like lights and power points regularly
- Clean all light fittings as and when necessary with the help of housekeeping personnel.
- Replace the defective bulbs, tubes, chokes, starters etc. on reimbursement basis.

1.4. Diesel Generator Sets

- Keep the D.G room clean
- Check sufficient amount of fuel, oil and water is available for running the DG sets.
- Check the starter battery, charger and electrolyte level in cells and top-up with distilled water if required.
- Check output voltage and frequency from generators through indicating meters.
- Co-ordinate with the AMC contractor / supplier for routine maintenance.
- Operate DG set manually if auto change over is not working.
- Co-ordinate with the vendors to perform B-Check, so that preventive maintenance can be carried out for the system.
- Operation and maintenance of the D.G. Sets in accordance with the Manufacturer's Instruction Manual.
- Run D.G. Sets in synchronization as well in auto mode and

independent.

- Maintain Hourly logbook and any abnormality to be brought in to notice.
- Refill the Day oil tank with requisite amount of HSD tank daily.
- Maintain the HSD stock at Min reorder Qty
- Maintain the register for daily consumption of HSD and follow up with Purchase Function of **BANK** for replenishment
- Check Electrical circuits and all the Panels on a daily basis
- Ensure no lube oil leak and HSD leakages from the DG Set and day oil tanks, as well no spillages while refilling the day oil tanks, clean DG sets on daily basis.
- Report any irregularity to the concerned
- Report Units generated by each DG Set every day and also the Per Unit Cost of each DG set.

1.5. Water Supply and Fire Fighting

- Operation and maintenance of all Water Supply and Fire Fighting Equipment as per the Equipment List including Pumps, in accordance with the manufacturer's Instruction Manual
- Ensure Water supply at facility (toilet and in outer areas, and garden) for 24 hours a day and 365 days a year across the plot.
- Fire alarm system – Main panel and secondary to be tested with acknowledge, alarm switch. During testing the panel should be operated on battery. Testing should be done once in two weeks
- Monitor that there is no over flow of water ever.
- Check of Water taps in toilets and in outer areas.
- Check & rectification of Oil Filters, gaskets, washers, Gauges, V-Belts, Engine Oils, Batter, Self and Engine Servicing of diesel Engines
- Check & rectify External & Internal Fire Hydrants – Control valves, First Aid Hose Reel, Hose Boxes & CP Hose
- Cleaning of Solar Water Heater panel at terrace at the interval of 7 days.

For Pump Control panel – Rectification of water level controllers, relays, fuses, main switches, indicators, contractors, amp. Meters, voltmeters, bulbar, and any modification of wiring/control circuit if required.

1.6.All Flats/Building and Carpentry Services

Civil Services and minor repair jobs provided by Bidder would include but not be limited to the following

- Carpentry Services provided under the general maintenance service would be limited to repair of damaged or worn out items. Matching of colours / texture / shades will be done to the closest shade readily available. Materials will be supplied by the contractor, or will be charged at cost.
- **Plumbing Services** provided under the General maintenance service would be limited to repair of damaged or worn-out existing items, with similar new / available items of similar / improved quality. Any addition / extension to an existing system or installation of a new item / system will be termed as a project and will be charged separately. Materials will be supplied by you, or will be charged at cost.

2. House Keeping Services

2.1.Daily Activities

- Thorough check of work force by supervisors for uniform, appearance, cleanliness and attendance before the start of work.
- Emptying of all garbage baskets and central collection of garbage waste.
- Cleaning of Common Area as often as possible.
- Periodic cleaning and mopping of the lifts, entrance and the floor lobbies and Toilet block (3-4 times a day).
- Cleaning of the Electric Rooms in the presence of the electrician in the course of the day. This cleaning would only involve sweeping and mopping of the floor and removal of dust and cobwebs from the wall and ceiling and dusting and cleaning of doors and windows. The equipment in the room would be cleaned by the persons operating them.
- Regular cleaning, dusting and mopping of common area
- Scheduled cleaning / dusting of electrical and other fitting fixtures in the common area.

- All dust and garbage shall be collected from bins at regular intervals at all the floors and disposed off in Municipal garbage bins. The contractor shall make necessary arrangement with the Municipality for the purpose. However the applicable Municipality / Nagar palika monthly charges for garbage collection will be paid by the Bank directly to Municipality / Nagar palika.

2.2 Cleaning of electrical chimney installed in Kitchen

- a. For MMM Marg Building – Contractor shall coordinate with chimney manufacturer (chimney cleaning contract service provider & OEM of chimney responsible for providing life time warranty of chimney) such as making complains related to chimney, follow up with chimney manufacturer for providing required mandatory cleanings of chimney at required interval. However, Bank will have chimney cleaning contract directly with chimney manufacturer and payments in this regard will be made directly by the Bank to chimney manufacturer.
- b. For Kings Apartment – Contract will clean the filters of the electric kitchen chimney / exhaust fan and mesh every alternate month including oiling and greasing of chimney fans.

2.3 Weekly Jobs:

- Review of the daily work schedule.
- Polishing of all metal as per defined or fixed schedules
- Removal of cobwebs and stains from walls and ceilings.
- Sweeping & mopping of the building stairways.
- Cleaning of artificial plants, if any.
- Collect paper waste for disposal to garbage collector.
- **Thorough cleaning of common area, toilets with soap water and disinfectants.**
- **Implement Planned Preventive Maintenance Schedule and maintain the same.**

3. Landscaping

- Complete Garden maintenance
- Maintenance of the planters
- Soil and manure would be added regularly to keep the plants healthy (cost of the consumables would be on re-imburement basis and at actual)
- Seeds for seasonal flowerbeds would be supplied at actual cost
- All the gardeners would be equipped with necessary tools and pesticides.
- Prune and trim hedges and plants
- Weed lawns and mow them regularly
- Spray pesticides regularly

4. Others

- a. The contractor shall take necessary steps to prevent water contamination and stagnation of water in the premises to prevent mosquito breeding.

During monsoon season, kerosene or burnt mobile shall be sprayed over stagnant water in the premises regularly to prevent breeding of dengue mosquitoes.

- b. Maintenance of plumbing works, rectification of leakages, carpentry repair etc., within the apartments shall be carried out free of cost (including cost of consumables for minor work upto ₹100/-) with an experienced plumber / carpenter. However, cost of replacement of parts / materials shall be reimbursed by SIDBI on actual basis.
- c. All electrical works within the apartments shall be maintained by the contractor including replacement of consumables. However, the cost of parts / material replaced (except tubelights & bulbs which will be provided by the occupants) shall be reimbursed by SIDBI on actual basis. Maintenance of electrical /plumbing/carpentry repair in common area shall be done by the contractor including replacement of consumables. The cost of replacement of parts / materials shall be reimbursed by SIDBI on actual basis. All fused lights in common area shall be replaced by the contractor. However, bulbs, tube lights & CFLs shall be provided by SIDBI and contractor shall maintain a register to keep record of replacements of the same.
- d. For reimbursement of the cost of parts / materials replaced by the contractor, the contractor should submit original bills for purchase of the parts / materials replaced duly signed by the occupants of the flats / care taker for common area. Payments shall be made after verification of rates by SIDBI.
- e. The contractor shall provide one electrician / technician round the clock (in shifts) daily (including holidays) in the complex who should attend operation of DG set, pump, inspection / repair of fire fighting system and electrical repairs in the flats. Duty hours of all other personnel shall be eight hours including holidays.
- f. All the works shall be supervised by a supervisor. The supervisor and all the workers shall also wear identity cards and proper uniform while they are in the complex.

Signature of the Contractor

Manpower Details

The contractor shall always employ a minimum strength of experienced staff at site as mentioned in tender. Necessary grooming should be done before posting the staff at site. He shall also comply with the provisions of all labour legislations. Receipt of any complaint on this ground shall be viewed seriously. No additional payment shall be made if contractor keeps more staff at site for completing the pending work or if the minimum staff strength is not able to perform satisfactorily as per contract provision.

For deduction purpose, @ `1000/- compensation per day per location shall be levied in case of absence / non-satisfactory work.

The workers / staff employed should wear colour code uniforms, pant+shirt+shoes+cap+gloves for male. Any indecent behavior / suspicious activities of the Staff employed shall be viewed seriously and a suitable penalty shall be levied on the contractor. The contractor is also required to submit the list of the workers with photo ID, educational qualification, address proof etc. before deputing the workers.

Contractor shall be solely responsible for the credentials / acts of his staff / workers.

Contractor is required to submit daily labour report duly signed by Asst. Care Taker (ACT) / Care taker (CT) to the Bank and other reports in desired format of Bank.

Contractor is required to make timely payment to his staff including various statutory authorities. The Bank reserves a right to check the same.

Essential Qualification :

The Supervisor should have an experience of Minimum 3 Years in Maintenance & Housekeeping Services of Residential complex. He shall be provided with Mobile Phone so that he may be contacted in case of any emergency.

Note:

1. The compensation /deductions as indicated above is minimum & the same may be increased on the discretion of Bank if there is no improvement is found in their performance.
2. All the tools & other accessories which are meant to be used for the Cleaning / Plumbing / Carpentry works / Gardening shall be provided by the Contractor engaged nothing shall be provided by the Bank except electricity & water.

3. Contractor shall be solely responsible for protection of his materials /for the protection of the Bank's property.
4. The Contractor cannot sublet any part work except pest control agency to anybody without prior permission of the Bank.
5. The Contractor is responsible for making timely payment to his employees / sub contractor (if any). Else the Bank reserves its right to pay the same & recover it from Contractor's payment n case need arises.
6. No other payments shall be made to the Contractor for doing the works as described in the Scope of works. No escalation on quoted rates shall be paid.

The suggested minimum manpower required for the maintenance of the building every day excluding holidays and Sundays is mentioned as below :

1. Supervisor – 1 no. (Timing 9.30 a.m. to 5.30 p.m.) on all working days and Saturdays.
2. Trained sweepers – 4 nos. (Timing from 8.30 a.m. till 4.30 p.m.) at least 2 sweepers should be available at each location.
3. Skilled Electrician - 2 nos Electricians (Timing 10.00 a.m. to 6.00pm) having electrical license or of proven competence, in consultation with SIDBI. However, electrician may be required any time during urgency on call basis.
4. Carpenter / Plumber – As and when required
5. Gardener – 1 no. half day at each location on all days.

Any manpower required on holidays / Sundays will be separately notified. Payment for the same will be made as per minimum wages applicable.

It may be noted that the timing and manpower as indicated above is minimum and may vary at the discretion of SIDBI. If required for proper execution of the work, manpower may be added / adjusted as per the requirement without any additional cost for same.

The contractor shall provide the following materials / services, the cost of which shall be included in the rate and no extra amount shall be paid for the same :

1. Vacuum Cleaner
2. All cleaning materials viz. Brooms, Dusters, Phenyl, Soap, Brasso, Cleaning Chemicals etc. same should be of reputed quality and Brand approved by Bank's Representative.

Carpentry Works

1. Repair of problematic locks of doors, cupboards and changing the same if required.
2. Minor repair of door, drawers, furniture etc. fixed at residential flats.

3. Minor carpentry repair works required for residential flats.
Cost of material will be reimbursed to the contractor on producing cash memo/ tax invoice and verification of rates.

II Maintenance of potted plants & plants / trees of common areas in the premises

- 4.1. Maintenance and development of plants / trees with adequate watering, trimming, manuring and providing necessary fertilizers, etc.
- 4.2. The cost of materials including plants, fertilizers etc. including manpower required for undertaking the job shall be borne by the contractor.

III Plumbing Works

1. **Rain water** pipes at terraces should be checked particularly during the rainy seasons. The khurrah should be cleaned weekly. The leaves etc at the kurrah should be removed. Seepage points if any found should be sealed by proper grouting. Cost of material if any provided / changed will be reimbursed to the contractor on producing cash memo/ tax invoice and verification of rates.
2. Surface drain should be checked periodically by removing the perforated grating and the drain should be got cleaned. Minimum once in six months cleaning is necessary.
3. Sewer line should be checked at random periodically. The flow of sewer water should be checked. In case of blockage, seepage, the same should be got removed. Cost of material if any provided / changed will be reimbursed to the contractor on producing cash memo/ tax invoice and verification of rates.

Water supply lines – All the water supply lines should be inspected once in 15 days and leakage / seepage / any other defect observed in the pipe line to be rectified. Cost of material if any provided / changed will be reimbursed to the contractor on producing cash memo/ tax invoice and verification of rates.

4. Sanitary Fixture – All the sanitary fixtures should be checked once in a week. The W.C.s should have proper water seal. The flushing cistern should flush properly. The leakage in the bottle traps of urinals, pantry sinks wash basin and floor traps at various location should be checked properly. In case any leakage / blockage the same should be got rectified through qualified plumbers. Cost of material if any, provided / changed will be reimbursed to the contractor on producing cash memo / tax invoice and verification of rates.
5. C.P. fittings – The aerators of all the C.P. fixtures should be checked twice a week. Normally aerators of C.P. fittings get blocked due to for particles in the water. The leakage in the C.P. Angles valves, bib tapes & mixer fittings should also be checked at least twice a week and should be rectified if observed. Cost of material if any provided / changed will be

reimbursed to the contractor on producing cash memo / tax invoice and verification of rates.

6. Checking and repairing of all leakages in all water supply, sanitary, rain water lines including traps and fittings.
7. Keeping record of water consumptions in office by maintaining the water meter reading daily basis.

Note :

1. The following materials are in scope of contractor which are to be replaced periodically:

Covered trolleys, Dustbins, dustpans, mops, buckets, wipers, gloves, dusters, scrubbers, sponge, brooms, brushes, safety gear Broom, Brush, Swabbing cloth, Washing brush, Mop stick, Coconut broom, Dust cleaning stick, dust collector brush, soft broom, WC round brush, Rubber wiper, cotton swab, Toilet/ kitchen vacuum pump, nylon scrubber, vacuum cleaner, metal broom, shovel, Glass duster, Big Plastic drum, Ladder, garbage trolley, Cost of laundry charges of the linen and any other materials required for cleaning but not covered are in scope of Contractor.

The following machineries are in scope of contractor:

Scrubbing machine, Auto scrubber machine, Wet/ dry vacuum cleaning machine, Lawn mower machine with roller and necessary tools & tackle for horticulture works.

2. No other payment shall be made for doing the woks described in scope and schedule of work. No escalation on quoted rates shall be paid.
3. All required tools and materials for plumbers, electrician and carpenter and for cleaning etc. shall be arranged in sufficient quantity by contractor at his own cost.
4. The contractor shall be solely responsible for protection of his material as well as the material handed over by the Bank.
5. The contractor shall be solely responsible for protection of Bank's property.
6. The contractor cannot sublet any part work without prior permission of the bank.
7. The contractor is responsible for making timely payment to his employees / sub contractors. Else the Bank reserves its right to pay the same and recover it from contractors payment, in case need arises.
