In this connection you are requested to offer technical bid and commercial offer with best price for supply and installation of new and refill the existing fire extinguishers in two different non window sealed envelope as per the details/ specifications given in the following Annexures:

Annexure -I

General Terms and Conditions

- The quotation submitted by the vendor/agency must be strictly in the enclosed format only with all heads duly filled in wherever applicable. The quotation submitted in any other format other than the format given in Annexure II & Annexure III may not be considered. The last date and time of receiving the sealed quotations shall be April 13, 2015 by 3:00 PM.
- 2. The technical & commercial bid should be duly signed by authorized signatory with date and seal. Unsigned/conditional bids/quotations will be rejected.
- **3. Period of validity**: Price quoted by the agency for fire extinguishers/refill of existing fire extinguishers must be valid till **August 01, 2015**.
- 4. Earnest Money Deposit [EMD] :

Demand draft for an amount of Rs. 8,000/- (Rupees Eight thousand only) drawn in favour of 'Small Industries Development Bank of India' payable at Lucknow. The Demand draft shall be enclosed with the technical bid in Envolop-1.

- 5. Refund of EMD:
- To unsuccessful Bidders: After award and acceptance of work by successful Bidder without any Interest.
- (ii) EMD of the successful bidder shall be considered as Initial Security deposit (ISD).
- (iii) If the successful bidder fails to accept the LOI / do not provide the required performance security deposit (SD) or expresses inability to carry out the work or fails to start the work within stipulated time, SIDBI shall forfeit the bid security amount (EMD) of the bidder and ban the contractor from subsequent bidding for a period of 3 years

6. Opening of Bids:

- **5.** (i) The Technical bids shall be opened on **April 13, 2015 by 3:30 PM.** It would be bidder's responsibility to depute the representative (one only) for the opening of bids. No separate communication in this regard shall be sent to the bidders
- (ii) The commercial bid will be opened after the scrutiny/short list of the technical bid submitted by the agencies.
- The bidders should be authorized reputed Lucknow / Utter Pradesh base dealer/suppliers of reputed BIS certified fire extinguisher manufacturer having ISI certification.
- 8. The new fire extinguisher having validity of minimum for <u>three years</u> and also must have warranty/ guarantee of three years from the date of installations.
- 9. The refilling of existing fire extinguishers shall be done after proper service, repair (if required), successful hydraulic testing, and certification should be valid for three years from date of refilling. The testing and refilling of same may also be conducted quarterly basis for the period of three years prior to the date of expiry or as and when required.

- 10. The price quoted must be inclusive of all taxes, levies, any other charges etc. No additional cost whatsoever other than the price quoted by the vendor will be paid by SIDBI.
- 11. **Period of Completion**: Total period of completion for the work (including supply, installation, testing, submission of all required and relevant documents/certificates, complete in all respect) shall not exceed 15 days from date of the Purchase order.
- 12. The rates quoted by you and accepted by us are deemed to be inclusive of all applicable taxes, viz. Income Tax and Trade Tax/ Service Tax/ levies, royalties, duties, octroi, other local bodies taxes and any other taxes if any etc. including sales tax on work contract which shall be paid by you to the concerned authorities. You shall indemnify SIDBI from any claim on such accounts whatsoever (copy of receipts / challans for such payments made should be submitted to SIDBI, if demanded). Rates quoted are fixed and will not change till the completion of the job and upto successful completion of warranty/guarantee period of five years from successful completion of the Job/work/services.
- 13. Security Deposit: The Bank will hold an amount of 10% of the total cost of work/job/ services as a security deposit (including of the EMD/ISD of Rs. 8,000/-) and the same shall be released without any interest after warranty/guarantee period and compressive AMC period of 3 (three) years from successful completion of the Job/work/services.
- 14. The agencies are requested to contact at above address for site visit (all three premises) and inspect the existing old fire extinguishers at various locations on working days between **April 01, 2015 to April 12, 2015 and 10 AM to 5 PM**.

15. Payment Terms

- a) 100% payment after deduction of security deposit (10% of total cost) within 15 days of successful supply, installation, completion of the said work at appropriate location as desired by the SIDBI or by as per relevant fire fighting/ fire protection code.
- b) Applicable taxes at source (TDS) will be deducted by SIDBI at the time of making payment.
- c) Payment shall be made electronically through RTGS/ NEFT by crediting the same to your bank a/c as per details provided in the Bank Mandate Form after successful supply, installation, execution of comprehensive AMC for period of 3 (three) years and complete in all respects.

16. Bank Mandate Form:

All the bidders are required to submit duly filled-in Bank Mandate Form as per format attached as Annexure III. Form should necessarily be accompanied a cancelled cheque leaf.

- ii. The bidder must be an authorized dealer/distributer of Lucknow based and having full flagged set up for supply, installation and refilling of ISI marked fire extinguishers. (Copy of dealer ship certificate must be attached).
- iii. The manufacture must have valid ISI Marked certificate, certified by BIS certification for Fire Extinguishers. (Manufacturer BIS Certification must be attached).
- iv. Experience certificates, preferable for Government Organizations/Institutions, departments, PSUs, Bank etc. (Copy of Work Order/Supply Order of last three years must be attached)

1, 2: Note on IFSC / MICR

Indian Financial System Code (IFSC) is an alpha numeric code designed to uniquely identify the bank-branches in India. This is 11 digit code with first 4 characters representing the bank's code, the next character reserved as control character (presently 0 appears in the fifth position) and remaining 6 characters to identify the branch. The MICR code, (Magnetic Ink Character Recognition) that appears on cheques, has 9 digits to identify the bank-branch. RBI had since advised all the banks to print IFSC on cheque leaves issued to their customers. A customer may also contact his bank-branch and get the IFS Code of that branch.
